Statistics Request Description

On January 24, 2024, Research & Statistics received a request from the Director of the Administrative Office of the Courts on behalf of the Co-Chair of the Interim Joint Committee on the Judiciary for a report examining trends over time in the rate of filing of Delinquency and Youthful Offender Filings including information about violent offenses. This report additionally includes information about Circuit Criminal cases filed against adult defendants as a point of comparison for these trends. To define violent offenses, Research & Statistics used the definition from KRS 532.200¹

CourtNet, which provides a summary of court cases statewide, was queried for cases filed between 1/1/2014 and 12/31/2023 within the following categories:

- **Circuit Criminal Cases:** Case Number Type *CR*, and
- **Delinquency Cases:** Case Number Type *J* (Juvenile) cases including a charge of at least one Public Offense and no Uniform Juvenile Codes indicating accusations of Dependency, Neglect, or Abuse.

Youthful Offender cases are identified as Circuit Criminal cases in which the top defendant party was 10-18² years of age as of the date of the earliest *Charge Date* for any charge in the case. All other Circuit Criminal cases are assumed in this report to be filed against adults, including 10,994 cases (0.8% of CR cases) with missing or implausible dates of birth (negative age, age 0, etc.).

Statistical Report

The following visualization demonstrates that while there have been increases over the last ten years both the number of Circuit Criminal cases filed against adults overall and the number of Circuit Criminal cases filed against adults including charges of violent offenses, the number of Delinquency

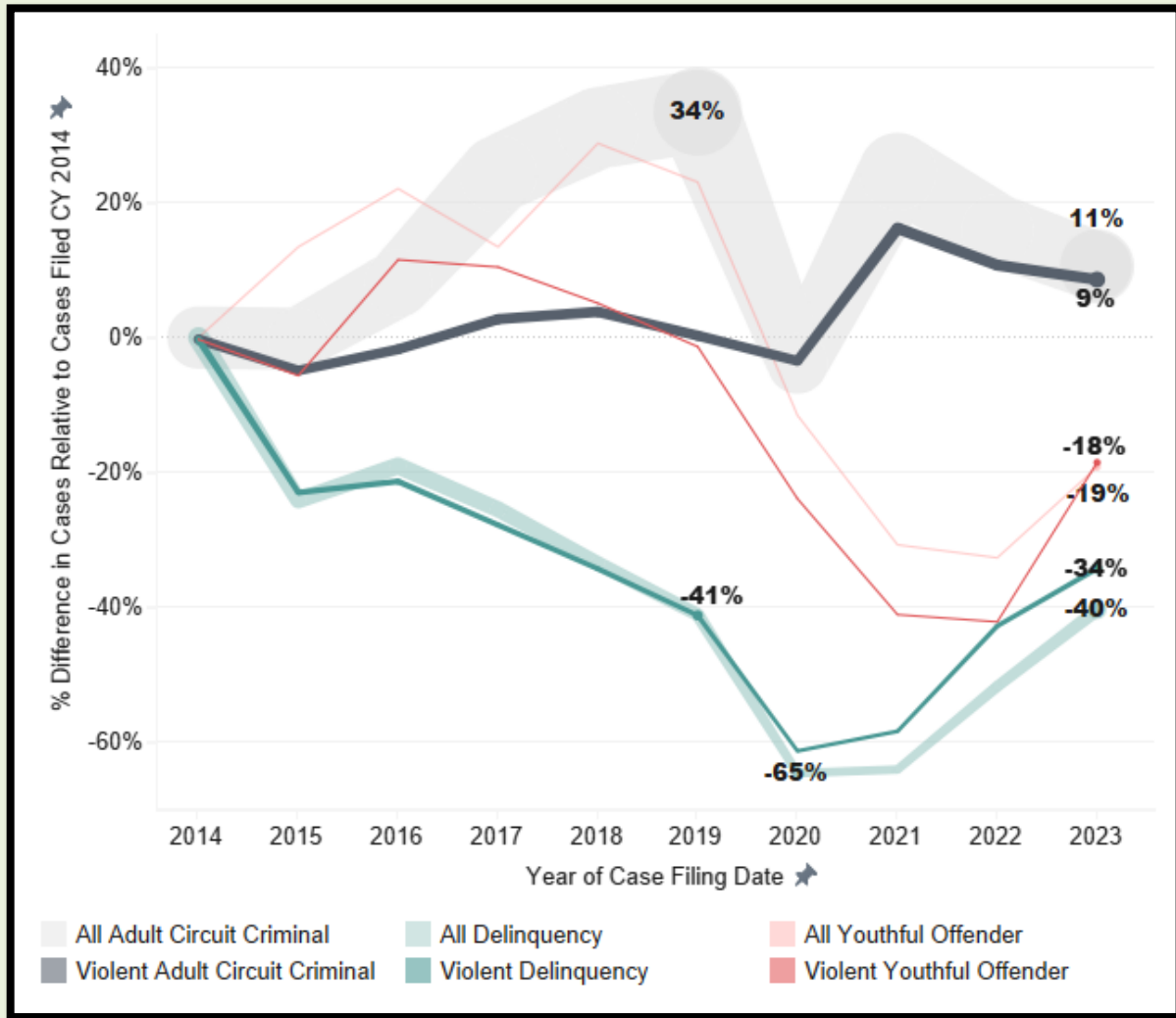

cases and Youthful Offender cases filed has declined, as has the number of these case including charges of violent offenses.

Figure 1: Percent difference in number of cases filed relative to cases filed in CY 2014



This visualization allows for the comparison of relative trends for groups of cases for which the actual numbers of cases are very different. The line chart presents the percent change in the number of cases filed in each of the indicated categories with vertical position representing the percent of each year's number of cases filed relative to the number filed in CY 2014. The size of each mark represents the relative number of cases in each group. The associated numbers of cases and percent differences are included in Table 1.

Preceding the COVID-19 pandemic of 2020, a steady increase in the number of Circuit Criminal case filed against adults is observed with peak numbers from Calendar Year (CY) 2019. Following a considerable decline in 2020, there was a slight spike in 2021 followed by a very slight decline in 2022 and 2023. The author's conjecture is that the spike in 2021 is likely in part procedural, with cases that

would have otherwise been filed earlier being delayed until the restoration of criminal jury trials in 2021. The largest month-to-month increase as well as the highest overall number of Circuit Criminal cases filed in a single month was March-to-April 2021, with an increase from 2,581 cases filed in March to 5,282 cases filed in April.³

The number of Circuit Criminal cases filed against adults including charges of violent offenses was relatively stable from 2014 to 2020, followed by a sharp increase in 2021 and a slight decrease thereafter. To the extent that these numbers also may be affected by the court closure and re-opening discussed above, this pattern may instead reflect a more gradual increase from 2019 to 2023.

While the numbers of Youthful Offender cases are much smaller (0.4% of Circuit Criminal cases overall and 1.9% of Circuit Criminal cases including violent charges) and therefore more vulnerable to noise, the patterns are similar from 2014 to 2019, with the same increase in overall numbers and general stability of numbers for cases with violent charges. However, following a similar decline in 2020, numbers for Youthful Offender cases continued to decline in 2021 and with a slight increase in 2023 still remain lower than any pre-pandemic years for both Youthful Offender cases overall and Youthful Offender cases including charges of violent offenses.

The years preceding the pandemic in 2020 include a consistent decline in the number of Delinquency cases filed. 2020 and 2021 include an even deeper decline with increase from 2021 to 2023 representing a return to approximately the same number of cases as were filed in 2019. The pattern for Delinquency cases including charges of violent offenses is very similar to the pattern observed for Delinquency cases overall.

Tables 1 and 2 on the subsequent pages present additional information. Table 1 includes the underlying numbers associated with the data presented in Figure 1. Table 2 presents numbers of cases and charges of specified types of offenses.

Statistical Analysis Considerations:

- These statistics represent a snapshot in time as of the date the data was queried (1/24/2024).
- Youthful Offender cases are frequently preceded by a Delinquency case and Grand Jury Indictment. As such, the Delinquency cases and Youthful Offender cases included in this report may not represent distinct incidents or youth.
