## CASES FILED WITH DUI CHARGES IN CALENDAR YEAR 2021 STATEWIDE

---

April 26, 2022

### Statistics Request Overall Description

On April 1, 2021, the University of Kentucky Transportation Center requested from Research and Statistics an update to four annual DUI case reports for calendar year 2021. These reports include the total number of cases filed with one or more DUI charges during calendar year 2021, the number of these cases filed and convicted within calendar year 2021, the number of these cases disposed in a manner other than conviction within calendar year 2021, and the number of these cases still pending as of December 31, 2021.

CourtNet, which provides a summary of cases statewide, was queried for cases including at least one DUI charge filed from January 1, 2021 through December 31, 2021. Cases with any pending charges, charges disposed later than 12/31/2021, or charges disposed as Failure to Appear (FTA) and Fugitive (FTV) were categorized as "pending". Cases that contain at least one convicted charge without any pending charges were categorized as "convicted." Cases containing neither pending or convicted charges were categorized as "cases disposed in a manner other than conviction."

### Statistical Tables (RS3060, RS3061, RS3062, RS3063)

There are four tables in this report. These tables display the number of cases including at least one DUI charge filed, convicted, or disposed in District Court.

1. RS3060: The number of cases including DUI charges filed during calendar year 2021.
2. RS3061: The number of these cases filed and also convicted during calendar year 2021.
3. RS3062: The number of these cases disposed in a manner other than conviction during calendar year 2021.
4. RS3063: The number of these cases still pending as of December 31, 2021.

Each of these tables includes the number of distinct cases grouped by county with a statewide total at the bottom.

### Statistical Analysis Considerations

- These statistics represent a snap shot in time as of the date of the query.
- Failure to Appear (FTA) and Fugitive (FTV) are temporary dispositions and are not included in table RS3062.
- Counts of cases count each case only once even though each case may include one or more DUI charges.
- Counts of cases do not represent counts of individual defendants as the same defendant may appear in multiple cases.

## Statistical Tables (RS3060, RS3061, RS3062, RS3063)

- A case may have multiple charges and each charge within a case may have different dispositions. Therefore, an individual case may be counted in more than one of the four reports.
