Statistics Request Overall Description

On February 8, 2024, Research and Statistics received a request for a report of the number of DUI charges disposed during calendar year (CY) 2023 in Hardin County.

The CourtNet database, which provides a summary of cases statewide, was queried for charges disposed during CY 2023 in Hardin County with an AOC Offense Group of DUI. A list of all offenses which comprise the data in the report is attached below.

Statistical Table (21_RSX4000 & 21_RSX4002)

Statistical Table 21_RSX6000: Provides a list of the DUI charges queried for the report sorted AOC Offense Category, UOR Code, UOR Description, and charge level and class.

Statistical Table 21_RSX6002: Provides counts of charges disposed in Hardin County during CY 2023.

Pages 1-3: Provide a cross-tabulation of charges disposed in Hardin County Circuit Court cases by UOR Code and Charge disposition category, with counts provided for charges and a distinct count of cases.

Pages 4-7: Provide a cross-tabulation of charges disposed in Hardin County District Court cases by UOR Code and Charge disposition category, with counts provided for charges and a distinct count of cases.

Page 12: Provides a summary of DUI charge dispositions, grouped by jurisdiction.

Statistical Analysis Considerations:

- Statistics represent a snapshot in time, as of the date the data was queried: 2/19/2024.
- A case may consist of one or multiple charges. The report's count of cases represents a distinct count of case numbers, regardless of the number of charges associated with the case.
- Counts of cases do not necessarily represent counts of unique individuals.
- Charges consist of all original and amended charges within a case counted separately.

DUI CHARGES DISPOSED DURING CY 2023 HARDIN COUNTY

Statistical Table (21_RSX4000 & 21_RSX4002)

- Many but not all charges heard in Circuit Court were previously heard in District Court and indicted by grand jury. As such, the sum of charges in District and Circuit Court will count some indicted charges twice and totals from the two jurisdictions are presented separately.

The AOC assigns and maintains codes that are used within the Court of Justice Case Management System for statistical and reporting purposes. These codes are used to identify local and city ordinances, as well as codes for general administrative purposes. The AOC official list of UOR Codes with KRS number and descriptor can be obtained at the Court of Justice Website at courts.ky.gov/aoc/statisticalreports. The AOC UOR Code Listing is for informational purposes only and the information is subject to change, reprogramming, modifications of format, and availability at the direction of the Administrative Office of the Courts (AOC).

A query for data based on specified charges will include each UOR code specified and possible supplemental codes. Supplemental codes (or "ASCF" codes) to any UOR code include: 1) attempt, 2) solicitation, 3) conspiracy, 4) facilitation, 5) complicity, and 6) enhancement. In total, UOR codes contain seven digits. The first six digits are specific to that charge. The seventh digit indicates if there is a supplemental code. A "0" as the seventh digit means that is the primary UOR code and it does not have a supplemental code. If there are supplemental codes, the "0" will change to a 1, 2, 3, 4, 5, or 6 (the numbering corresponds to the list above). An enhancement does not exist on all UOR codes. When a supplemental code does not appear within a dataset, charge(s) did not occur during this period. The presence of "*obs" within the description of a UOR code indicates an obsolete UOR code. However, the code is still present within the KYCourts/CourtNet database and may still be utilized. Not every UOR code included in the query will have charges associated with it in each calendar year examined. Some cases may contain multiple charges; therefore, charge counts may exceed case counts. The number of cases cannot be inferred as the number of individuals as multiple cases may have the same defendant.
