Statistics Request Overall Description

On February 8, 2022, the Office of the Pulaski County Attorney requested from Research and Statistics the DUI dispositions for Pulaski county calendar years (CY) 11- 21.

CourtNet, which provides a summary of cases statewide, was queried for DUI offenses having a charge disposition date between the specified timeframe of 1/1/2011 – 12/31/2021 in Pulaski county. This data will be used to calculate the percentages by disposition per DUI Offense groups (DUI 1st, DUI 2nd, DUI 3rd, DUI 4th and DUI Other).

Statistical Analysis Considerations:

- These statistics represent a snapshot in time as of February 19, 2022.
- A case may consist of two or multiple charges. The report's count of cases represents a distinct count of case numbers, regardless of the number of charges associated with the case.
- Counts of cases do not necessarily represent counts of unique individuals. Charges consist of all original and amended charges within a case.

However, the code is still present within the KYCourts/CourtNet database and may still be utilized. Not every UOR code included in the query will have charges associated with it in each calendar year examined. Some cases may contain multiple charges; therefore, charge counts may exceed case counts. The number of cases cannot be inferred as the number of individuals as multiple cases may have the same defendant.

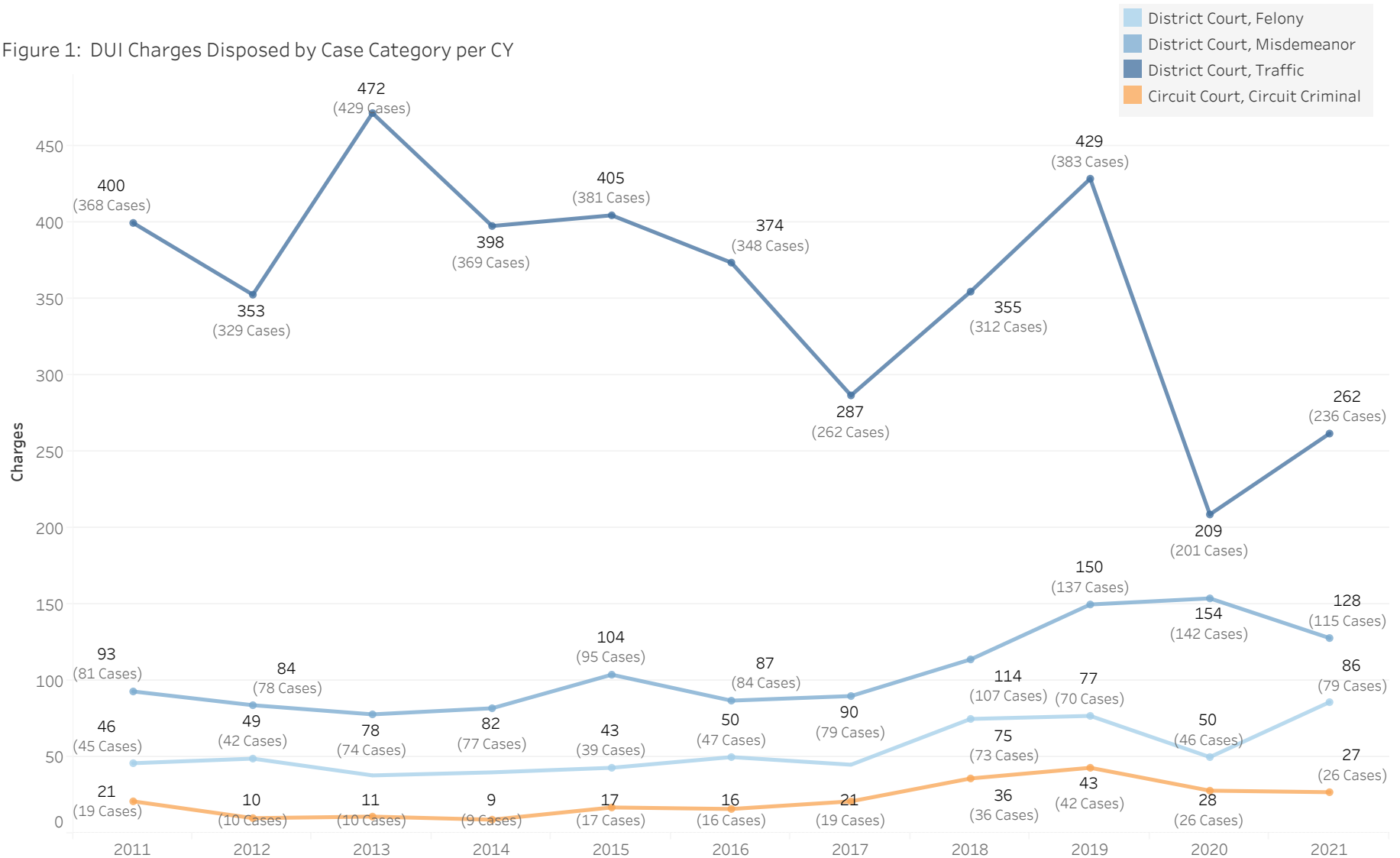

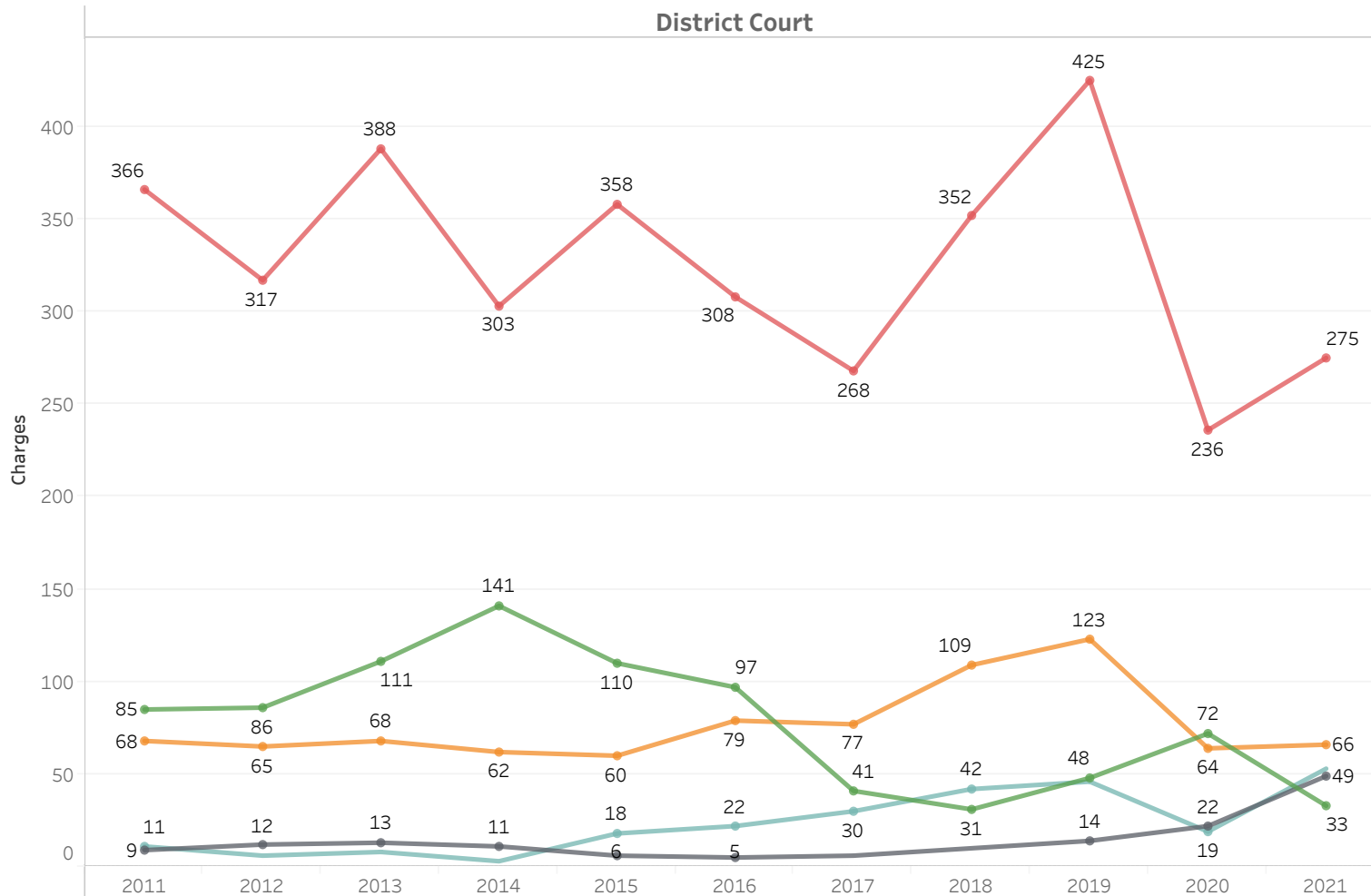

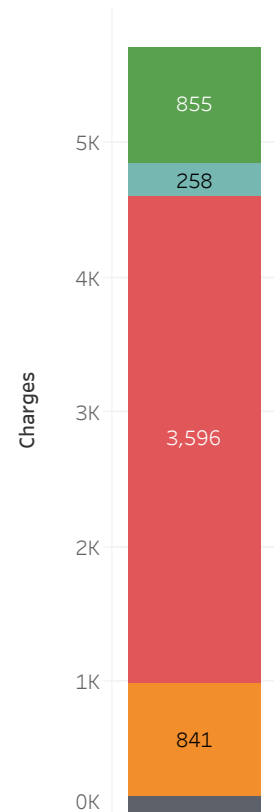

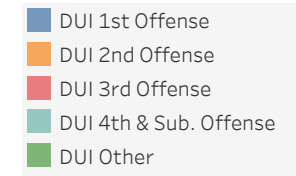
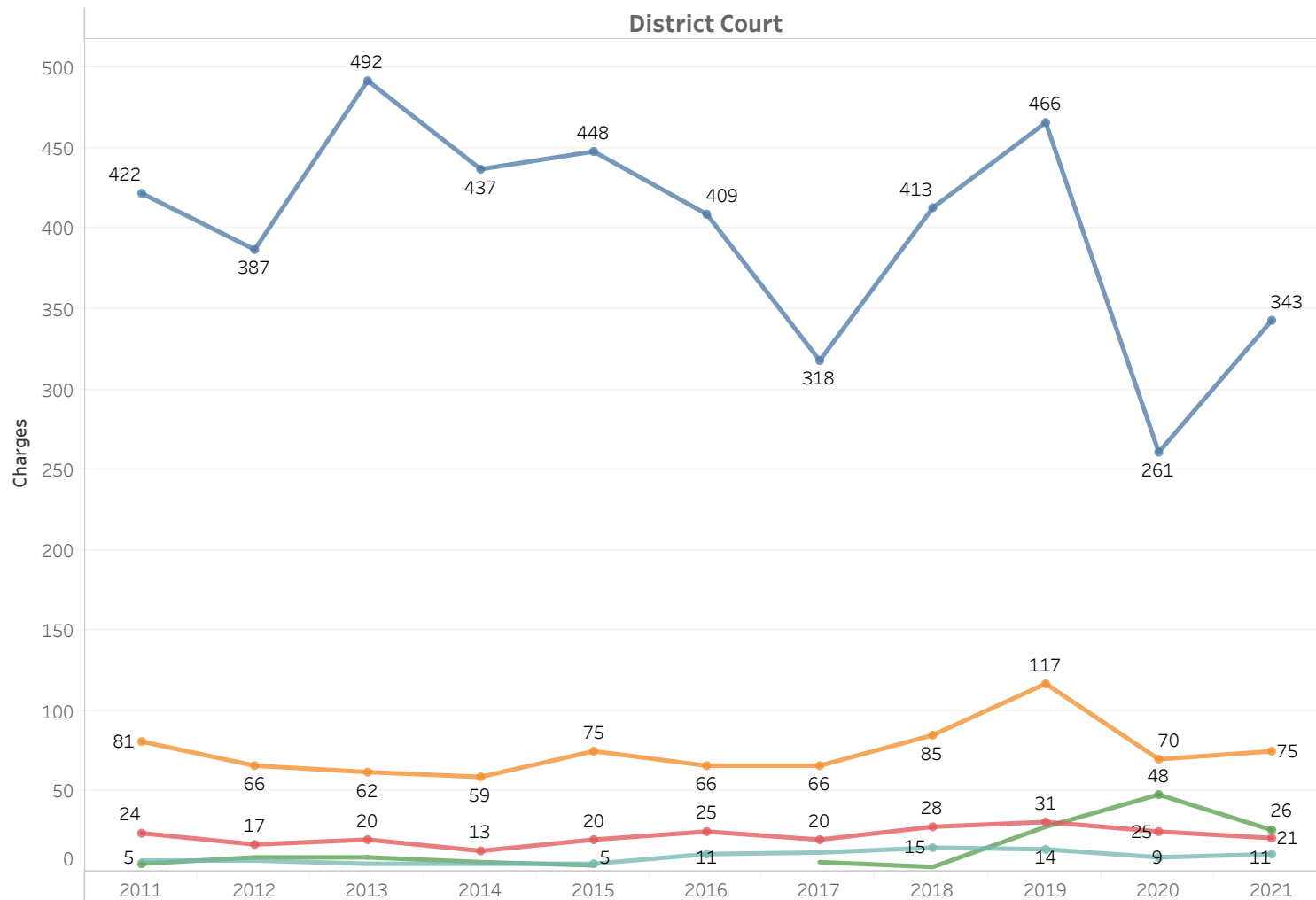

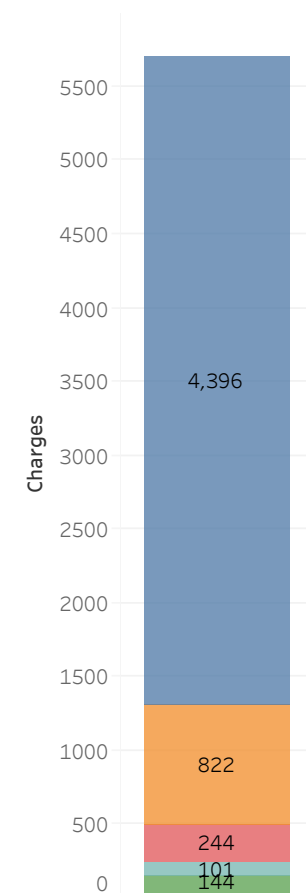
