KRS CHAPTER 209 CHARGES WITHIN CASES FILED AND CHARGES CONVICTED FISCAL YEAR 2022 STATEWIDE

Statistics Request Overall Description

On October 5, 2022, the Cabinet for Family and Children's Services requested a statewide count of KRS Chapter 209 charges within cases filed and charges convicted during fiscal year (FY) 2022.

CourtNet, which provides a summary of cases statewide, was queried for charges within cases filed and charges convicted statewide July 1, 2021 and June 30, 2022.

Statistical Table (21_RSX4000, 21_RSX4001, and 21_RSX4003)

Statistical Tables:

21_RSX4000 displays the requested charges queried for this report.

21_RSX4001 provides a count of the specified charges within cases filed with separate tables for each jurisdiction and is cross-tabulated by UOR code with description and the fiscal year.

21_RSX4003 provides a count of the specified charges convicted, with separate tables for each jurisdiction and is cross-tabulated by UOR code with description and the fiscal year.

Statistical Analysis Considerations:

- These statistics represent a snapshot in time, as of the date the data was queried: 10/10/22.
- A case may consist of one or multiple charges. The report's count of cases represents a distinct count of case numbers, regardless of the number of charges associated with the case.
- Counts of cases do not necessarily represent counts of unique individuals.
- Charges consist of all original and amended charges within a case.
- Charges include ASCF Codes: 1 - Attempt, 2 - Solicitation, 3 - Conspiracy, 4 - Facilitation, 5 - Complicity, 6 - Enhancement.
- Charge and case counts are displayed for CY 2015-2016 when an offense was convicted in the specified court division.

The first six digits are specific to that charge. The seventh digit indicates if there is a supplemental code. A "0" as the seventh digit means that is the primary UOR code and it does not have a supplemental code. If there are supplemental codes, the "0" will change to a 1, 2, 3, 4, 5, or 6
