



## HUMAN TRAFFICKING CHARGES DISPOSED CALENDAR YEARS 2007 - 2022 STATEWIDE

April 24, 2023

### Statistics Request Overall Description

On April 17, 2023, the Office of the Attorney General requested from Research and Statistics the number of human trafficking charges disposed since calendar years (CY) 2007 through 2022.

CourtNet, which provides a summary of cases statewide, was queried for charges of the human trafficking offenses included in the attached list disposed between 1/1/2007 and 12/31/2022.

### Statistical Table 21\_RS8016

The report includes two cross-tabulations presenting the number of human trafficking charges disposed during the requested date range grouped by offense and disposition category as well as totals and a grand total for each jurisdiction. The first table includes charges disposed in Circuit Court and the second table includes charges disposed in District Court. A list of the offenses queried is also included.

#### Statistical Analysis Considerations:

- The data provided is a snapshot in time as of the date the data was queried: 4/24/2023.
- A case may consist of one or multiple charges. The report's count of cases represents a distinct count of case numbers, regardless of the number of charges associated with the case.
- Counts of cases do not necessarily represent counts of unique individuals.
- Charges consist of all original and amended charges within a case.
- Charges include ASCF Codes: 1 - Attempt, 2 - Solicitation, 3 - Conspiracy, 4 - Facilitation, 5 - Complicity, 6 - Enhancement.

The Kentucky State Police (KSP) assigns the Kentucky Uniform Crime Reporting Codes (UOR Codes) to criminal offenses in the Commonwealth of Kentucky. The KSP official list of UOR Codes by KRS number and descriptor can be obtained at the KSP's website at [www.kentuckystatepolice.org](http://www.kentuckystatepolice.org).

The AOC assigns and maintains codes that are used within the Court of Justice Case Management System for statistical and reporting purposes. These codes are used to identify local and city ordinances, as well as codes for general administrative purposes. The AOC official list of UOR Codes with KRS number and descriptor can be obtained at the Court of Justice Website at [Analytics - Kentucky Court of Justice \(kycourts.gov\)](https://www.kycourts.gov). The AOC UOR Code Listing is for informational purposes only and the information is subject to change, reprogramming, modifications of format, and availability at the direction of the Administrative Office of the Courts (AOC).

A query for data based on specified charges will include each UOR code specified and possible supplemental codes. Supplemental codes (or "ASCF" codes) to any UOR code include: 1) attempt, 2) solicitation, 3) conspiracy, 4) facilitation, 5) complicity, and 6) enhancement. In total, UOR codes contain seven digits. The first six digits are specific to that charge. The seventh digit indicates if there is a supplemental code. A "0" as the seventh digit means that is the primary UOR code and it does not have a supplemental code. If there are supplemental codes, the "0" will change to a 1, 2, 3, 4, 5, or 6 (the numbering corresponds to the list above). An enhancement does not exist on all UOR codes. When a supplemental code does not appear within a dataset, charge(s) did not occur during this period. The presence of "\*obs" within the description of a UOR code indicates an obsolete UOR code. However, the code is still present within the KYCourts/CourtNet database and may still be utilized. Not every UOR code included in the query will have charges associated with it in each calendar year examined. Some cases may contain multiple charges; therefore, charge counts may exceed case counts. The number of cases cannot be inferred as the number of individuals as multiple cases may have the same defendant.
