Statistics Request Overall Description

On April 11, 2024, Research and Statistics received a request from a member of the news media for an aggregate report of filings and dispositions for charges of convicted felon in possession of a handgun or firearm, theft by unlawful taking of a firearm or receiving a stolen firearm, possession of a defaced firearm or defacing a firearm, attempted murder, first degree rape, first and second degree assault, first and second degree robbery, and first degree wanton endangerment for calendar years (CY) 2017, 2018, 2019, 2022, and 2023 in Jefferson County. Additionally, it was requested that only base charges be included, with the exception of attempted murder.

The CourtNet database, which provides a summary of cases statewide, was queried for the specified charges filed or disposed in Jefferson County for CYs 2017, 2018, 2019, 2022, and 2023.

Statistical Tables (24_RS6024)

Statistical Table 24_RS6024: Provides 13 pages of data aggregations which display information on the specified charges which were filed or disposed in Jefferson County during CYs 2017, 2018, 2019, 2022, and 2023. Additionally, counts of distinct cases containing those charges are provided.

Page 1: Provides two cross-tabulations. The upper table displays an overall count of specified charges filed grouped by Charge Filing Year. The lower table provides overall counts of specified charges disposed, grouped by Disposition Group, Conviction Type (If Applicable), and Charge Disposition Year. For both tables, a count of distinct cases which contain those charges is provided for each grouping.

Pages 2-3: Provide a cross-tabulation that displays counts of specified charges filed sorted by AOC Offense Category and grouped by UOR Code and Charge Filing Year. Additionally, a count of distinct cases which contain those charges is provided for each grouping.

Pages 3-12: Provide a cross-tabulation that displays counts of specified charges filed sorted by AOC Offense Category and grouped by UOR Code, Disposition Group, Conviction Type, and Charge Disposition Year. Additionally, a count of distinct cases which contain those charges is provided for each grouping.

Statistical Tables (24_RS6024)

Page 13: Provides a list of all charges found in the report sorted by AOC Offense Category, UOR Code, UOR Description, and Charge Level and Class.

Statistical Analysis Considerations:

- Statistics represent a snapshot in time, as of the date the data was queried: 4/22/2024.
- A case may consist of one or multiple charges. The report's count of cases represents a distinct count of case numbers, regardless of the number of charges associated with the case.
- Counts of cases do not necessarily represent counts of unique individuals as the same defendant may appear in multiple cases.
- Charges consist of all original and amended charges within a case counted separately.
- A case may consist of charges which fall under different groupings within a table. In this situation, a case is added to the case count for each grouping which applies to at least one charge within a case. Each subtotal displays the quantity of distinct cases and charges for that grouping, causing subtotals of case counts to add up to a number greater than the actual overall total.

The AOC assigns and maintains codes that are used within the Court of Justice Case Management System for statistical and reporting purposes. These codes are used to identify local and city ordinances, as well as codes for general administrative purposes. The AOC official list of UOR Codes with KRS number and descriptor can be obtained at the Court of Justice Website at <https://www.kycourts.gov/AOC/Information-and-Technology/Analytics>. A query for data based on specified charges will include each UOR code specified and possible supplemental codes. The first six digits are specific to that charge. The seventh digit indicates if there is a supplemental code. If there are supplemental codes, the "0" will change to a 1, 2, 3, 4, 5, or 6 (the numbering corresponds to the list above). An enhancement does not exist on all UOR codes. When a supplemental code does not appear within a dataset, charge(s) did not occur during this period. The presence of "*obs" within the description of a UOR code indicates an obsolete UOR code. However, the code is still present within the KYCourts/CourtNet database and may still be utilized. Not every UOR code included in the query will have charges associated with it in each calendar year examined. Some cases may contain multiple charges; therefore, charge counts may exceed case counts. The number of cases cannot be inferred as the number of individuals as multiple cases may have the same defendant.
