### Statistics Request Overall Description

On February 29, 2024, Research and Statistics received a request from the Office of the Boone County Attorney for a report of the number of specified charges within cases filed and the same charges disposed calendar years 2020 through 2023 in Boone County.

The CourtNet database, which provides a summary of cases statewide, was queried for charges filed and charges disposed from 1/1/2020 through 12/31/2023 in Boone County. A list of all offenses which comprise the data in the report is attached below.

**Statistical Table 21\_RSX4000:** Provides a list of the requested charges queried for the report sorted by KRS, UOR Code, UOR Description, and charge level and class.

Statistical Analysis Considerations:

- Statistics represent a snapshot in time, as of the date the data was queried: 3/6/2024.
- A case may consist of one or multiple charges. The report’s count of cases represents a distinct count of case numbers, regardless of the number of charges associated with the case.
- Counts of cases do not necessarily represent counts of unique individuals.
- Charges consist of all original and amended charges within a case counted separately.
- Many, but not all, charges heard in Circuit Court were previously heard in District Court and indicted by grand jury. As such, the sum of charges in District and Circuit Court will count some indicted charges twice and totals from the two jurisdictions are presented separately.

Not every UOR code included in the query will have charges associated with it in each calendar year examined. Some cases may contain multiple charges; therefore, charge counts may exceed case counts. The number of cases cannot be inferred as the number of individuals as multiple cases may have the same defendant.
