### Statistics Request Overall Description

On February 2, 2024, Research and Statistics received a request for a report of the number of substance-related charges disposed during calendar year (CY) 2023 in Pulaski County.

The CourtNet database, which provides a summary of cases statewide, was queried for charges disposed during CY 2023 in Pulaski County and were either associated with KRS 218A or had a listed drug type. A list of all offenses which comprise the data in the report is attached below.

### Statistical Table (21\_RSX4000 & 21\_RSX4002)

**Statistical Table 21\_RSX6000:** Provides a list of the substance-related charges queried for the report sorted Kentucky Revised Statute, UOR Code, UOR Description, and charge level and class.

**Statistical Table 21\_RSX6002:** Provides counts of charges disposed in Pulaski County during CY 2023.

**Pages 1-5:** Provide a cross-tabulation of charges disposed in Pulaski County Circuit Court cases by UOR Code and Charge disposition category, with counts provided for charges and a distinct count of cases.

**Pages 6-11:** Provide a cross-tabulation of charges disposed in Pulaski County District Court cases by UOR Code and Charge disposition category, with counts provided for charges and a distinct count of cases.

**Page 12:** Provides a summary of substance-related charge dispositions, grouped by jurisdiction.

#### Statistical Analysis Considerations:

- Statistics represent a snapshot in time, as of the date the data was queried: 2/9/2024.
- A case may consist of one or multiple charges. The report's count of cases represents a distinct count of case numbers, regardless of the number of charges associated with the case.
- Counts of cases do not necessarily represent counts of unique individuals.
- Charges consist of all original and amended charges within a case counted separately.

## SUBSTANCE-RELATED CHARGES DISPOSED DURING CY 2023 PULASKI COUNTY

### Statistical Table (21\_RSX4000 & 21\_RSX4002)

- Many but not all charges heard in Circuit Court were previously heard in District Court and indicted by grand jury. As such, the sum of charges in District and Circuit Court will count some indicted charges twice and totals from the two jurisdictions are presented separately.
