



**TRUANCY COMPLAINTS FILED FY 2017-2022 STATEWIDE
 INCLUDING AVERAGE AND MEDIAN NUMBER OF DAYS ABSENT/TARDY**

Statistics Request Overall Description

On June 23, 2022, Research and Statistics received a request for a report on habitual truancy complaints filed during fiscal year (FY) 2018-2022 statewide, including details for the average and median number of unexcused absences and tardies per complaint county.

Data was retrieved from two databases: AOC CDWCMS and CourtNet. AOC CDWCMS, the case management and information system used by AOC CDW, was queried for CDW complaints entered from July 1, 2017 to June 30, 2022 including charges of any of the offenses listed below by UOR Code. Court cases filed during CY 2015-2016 including the Habitual Truant status charge (UOR Code 0028020) were then extracted from CourtNet, which provides a summary of cases statewide.

The report 22_CDW3035 consists of two pages with a horizontal bar chart and cross-tabulations. The first page summarizes the number of days absent within habitual truant complaints filed statewide by the fiscal year of the complaint filing date (FY 2018 through FY 2022). The second page provides the number of days tardy for the same set of complaints.

The report 22_CDW3036 consists of twelve pages reporting a count of complaints filed and the average and median number of days **absent/tardy** within those habitual truant complaints filed by the fiscal year of the complaint filing date (FY 2018 through FY 2022) for each county.

Pages 1-3: This cross-tabulation presents a count of habitual truancy complaints filed, along with the average number of absences and the median number of absences by county per FY. It is grouped by County and sorted by FY of the complaint filing date.

Pages 4-6: This cross-tabulation presents a summary count of habitual truancy complaints filed, along with the average number of absences and the median number of absences by county.

Pages 7-9: This cross-tabulation presents a count of habitual truancy complaints filed, along with the average number of tardies and the median number of tardies by county per FY. It is grouped by County and sorted by FY of the complaint filing date.

Pages 10-12: This cross-tabulation presents a summary count of habitual truancy complaints filed, along with the average number of tardies and the median number of tardies by county.

Statistical Analysis Considerations:

- The statistical information presented is a snapshot in time as of July 5, 2022.
- Data provided from the Court Designated Workers Case Management System (CDW CMS) Database.
- Counts are of distinct complaints. A single juvenile may have multiple complaints, and a single complaint may contain one or more charges.
- In order to protect the identities of individuals associated with confidential records, reports conceal any instances in which five or fewer cases would have been reported. Blank data points should be considered to reflect “zero to five cases”. Any cases hidden in this manner are included in totals or subtotals provided that these totals or subtotals include six or more cases themselves.

AOC CDWCMS	FY	Indicates the timeframe from July 1 to June 31. For this request, the fiscal years are FY 2018 to FY 2022, which is based on the date the complaint was filed.
	Complaint Filing Date	The date the complaint was filed with the Court Designated Worker program. The chart and crosstab which focus on complaints filed include complaints filed during FY 2018-2022 as of 6/30/2022.
	Complaint	A verified statement containing allegations against a youth. A complaint may have one or more charges, and a youth may have one or more complaints. The count of complaints filed (referral entered) during the requested timeframe include only those with Habitual Truant charge(s).
	Truancy	In KY, a youth is considered truant when they have three unexcused events from school. At six unexcused events, they are considered to be habitually truant, which is grounds to file a complaint.
	Tardy	A late arrival to school.
	Absence	Represents missing a partial day or full day (so for example, only coming in the second half of the day, leaving at noon, or not coming to school at all that day).

The AOC assigns and maintains codes that are used within the Court of Justice Case Management System for statistical and reporting purposes. These codes are used to identify local and city ordinances, as well as codes for general administrative purposes. The AOC official list of UOR Codes with KRS number and descriptor can be obtained at the Court of Justice Website at courts.ky.gov/aoc/statisticalreports. The AOC UOR Code Listing is for informational purposes only and the information is subject to change, reprogramming, modifications of format, and availability at the direction of the Administrative Office of the Courts (AOC).

A query for data based on specified charges will include each UOR code specified and possible supplemental codes. Supplemental codes (or "ASCF" codes) to any UOR code include: 1) attempt, 2) solicitation, 3) conspiracy, 4) facilitation, 5) complicity, and 6) enhancement. In total, UOR codes contain seven digits. The first six digits are specific to that charge. The seventh digit indicates if there is a supplemental code. A "0" as the seventh digit means that is the primary UOR code and it does not have a supplemental code. If there are supplemental codes, the "0" will change to a 1, 2, 3, 4, 5, or 6 (the numbering corresponds to the list above). An enhancement does not exist on all UOR codes. When a supplemental code does not appear within a dataset, charge(s) did not occur during this

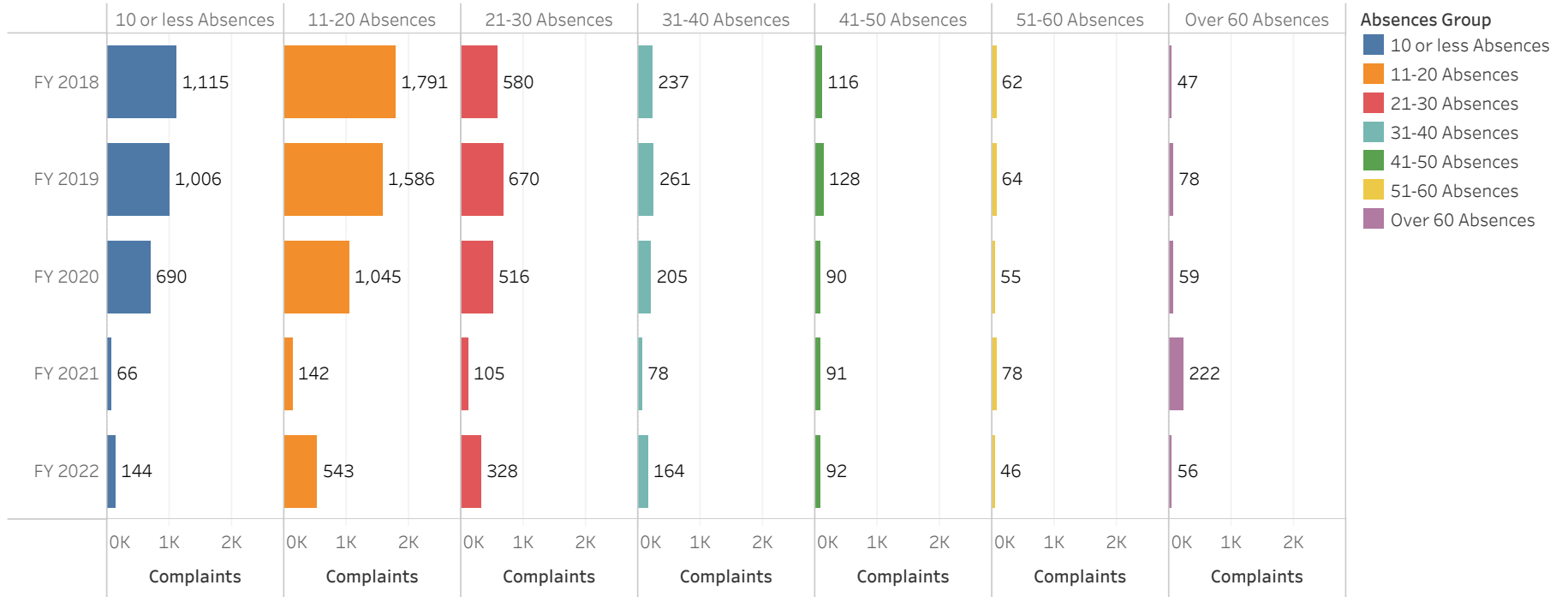

period. The presence of “*obs” within the description of a UOR code indicates an obsolete UOR code. However, the code is still present within the KYCourts/CourtNet database and may still be utilized. Not every UOR code included in the query will have charges associated with it in each calendar year examined. Some cases may contain multiple charges; therefore, charge counts may exceed case counts. The number of cases cannot be inferred as the number of individuals as multiple cases may have the same defendant.

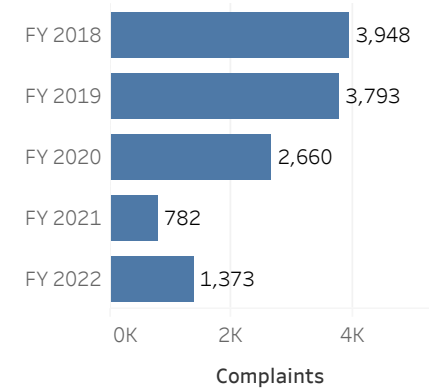

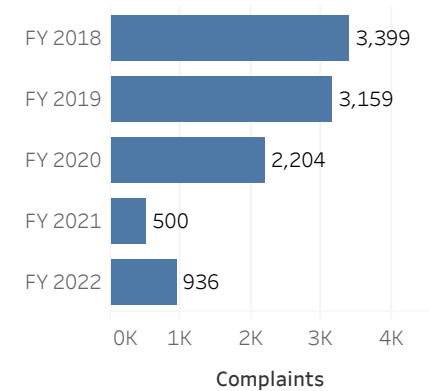
