Signage Notice for September 27, 2021

Justices, Judges, Circuit Court Clerks & AOC Executive Officers and Managers:

Entrance signs regarding masks being encouraged or mandated are now available in other languages

The Supreme Court issued [Administrative Order 2021-27](#) Aug. 9 to provide direction about when to wear masks in court facilities and who may enter court facilities based on [Centers for Disease Control](#) guidance in the wake of the Delta surge.

At that time, we updated our entrance signs to reflect those changes and asked you to post the sign that states the status of your facility:

- Sign 1, P-185, Aug. 9, 2021: Masks Encouraged Not Mandated (English and 11 other language)
- Sign 2, P-186, Aug. 9, 2021: Masks Mandated in 100% KCOJ Facilities (English and Spanish)
- Sign 3, P-187, Aug. 9, 2021: Masks Mandated in Mixed-Use Facilities (English and Spanish)

The first sign is for court facilities where mask usage is strongly encouraged regardless of vaccination status, but where the chief circuit judge has not mandated masks. The second sign is for facilities that are 100% occupied by the Kentucky Court of Justice and the chief circuit judge has mandated mask usage. The third sign is for mixed-used facilities where the chief circuit judge has mandated mask usage in the spaces occupied by the KCOJ.
