Statistics Request Overall Description

On January 29, 2025, Research and Statistics received a request for an aggregate report of attempted murder charges disposed in Franklin County from calendar year (CY) 2014 through calendar year 2024.

The CourtNet database, which provides a summary of cases statewide, was queried for charges with an AOC Offense Category of *Murder* and an ASCF code of 1, indicating that the offense was an attempt, that were disposed in Franklin County from CY 2014 through CY 2024. A list of offenses included in the query is attached below.

Statistical Reports (21_RSX6000 & 21_RSX6002)

Statistical Report 21_RSX6000 provides a list of charges queried for the report by AOC Offense Category, KRS, UOR Code, UOR Description, and Charge Level and Class.

Statistical Report 21_RSX6002 provides 7 pages of data aggregations containing counts of the specified murder charges that were disposed in Franklin County between 1/1/2014 and 12/31/2024.

Pages 1-4 provide a cross-tabulation of specified charges disposed in Franklin County by Jurisdiction, Calendar Year, UOR Code, and Charge Disposition Category. Additionally, counts of distinct cases containing those charges are provided.

Pages 5-6 provide a cross-tabulation of specified charges disposed in Franklin County by Jurisdiction, UOR Code, and Charge Disposition Category. Additionally, counts of distinct cases containing those charges are provided.

Pages 7 provides a cross-tabulation of specified charges disposed in Franklin County by Jurisdiction and Charge Disposition Category. Additionally, counts of distinct cases containing those charges are provided.

Statistical Reports (21_RSX6000 & 21_RSX6002)

Statistical Analysis Considerations:

- Statistics represent a snapshot in time, as of the date the data was queried: 2/10/2025.
- A case may consist of one or multiple charges. The report's count of cases represents a distinct count of case numbers, regardless of the number of charges associated with the case.
- Counts of cases do not necessarily represent counts of unique individuals.
- Charges consist of all original and amended charges within a case counted separately.
- Many but not all charges heard in Circuit Court were previously heard in District Court and indicted by grand jury. As such, the sum of charges in District and Circuit Court will count some indicted charges twice and totals from the two jurisdictions are presented separately.

The seventh digit indicates if there is a supplemental code. A "0" as the seventh digit means that is the primary UOR code and it does not have a supplemental code. If there are supplemental codes, the "0" will change to a 1, 2, 3, 4, 5, or 6 (the numbering corresponds to the list above). An enhancement does not exist on all UOR codes. When a supplemental code does not appear within a dataset, charge(s) did not occur during this period. The presence of "*obs" within the description of a UOR code indicates an obsolete UOR code. However, the code is still present within the KYCourts/CourtNet database and may still be utilized. Not every UOR code included in the query will have charges associated with it in each calendar year examined. Some cases may contain multiple charges; therefore, charge counts may exceed case counts. The number of cases cannot be inferred as the number of individuals as multiple cases may have the same defendant.
