Statistics Request Overall Description

On November 8, 2024, Research and Statistics received a request for an aggregate report of the count of DUI convictions statewide during calendar years (CY) 2012 – 2022, including statistics on defendants being convicted of DUI 1st Offense and having a subsequent DUI conviction within 10 years of the first.

The CourtNet database, which provides a summary of cases statewide, was queried statewide for cases containing at least one charge convicted between January 1, 2012 and December 31, 2022 having an AOC Offense Group of DUI.

Statistical Report (24_RS7029)

The requested data is contained in the attached report as described below:

Page 1: DUI Charges Convicted Statewide

This page consists of two (2) crosstabs containing statewide DUI charges convicted.

- The top crosstab displays DUI 1st Offense charges convicted during the requested timeframe. It is grouped by AOC Offense Category and sorted by the CY of the charge disposition date. Counts of charges and distinct cases are included.
- The bottom crosstab displays DUI 2nd, DUI 3rd and DUI 4th Offense charges convicted during the requested timeframe. It is grouped by AOC Offense Category and sorted by the CY of the charge disposition date. Counts of charges and distinct cases are included.

Pages 2 - 6: DUI 1st Charges Convicted by County

These five (5) pages contain a crosstab that displays DUI 1st Offense charges convicted during the requested timeframe. It is grouped by County and AOC Offense Category and is sorted by the CY of the charge disposition date. Counts of charges and distinct cases are included.

Pages 7 – 21: DUI 2nd, DUI 3rd and DUI 4th Charges Convicted by County

These pages contain a crosstab that displays DUI 2nd, DUI 3rd and DUI 4th Offense charges convicted during the requested timeframe. It is grouped by County and AOC Offense Category and is sorted by the CY of the charge disposition date. Counts of charges and distinct cases are included.

Page 22: Subsequent DUI Offense Charges convicted within 10 years of DUI 1st Statewide

Statistical Report (24_RS7029)

This page consists of a single crosstab that displays DUI 2nd, DUI 3rd and DUI 4th Offense charges convicted within 10 years of a DUI 1st offense conviction for any defendant data that could be matched using defendant's Criminal History Key. It is grouped by AOC Offense Category and is sorted by the number of years between the DUI 1st Conviction and the Conviction date of the subsequent DUI conviction. Counts of charges and distinct cases are included.

Pages 23 - 38: Subsequent DUI Offense Charges convicted within 10 years of DUI 1st by County

This page consists of a single crosstab that displays DUI 2nd, DUI 3rd and DUI 4th Offense charges convicted within 10 years of a DUI 1st offense conviction for any defendant data that could be matched using defendant's Criminal History Key. It is grouped by County and AOC Offense Category and is sorted by the number of years between the DUI 1st Conviction and the Conviction date of the subsequent DUI conviction. Counts of charges and distinct cases are included.

Defendant data was queried for all cases included in the data set. For *Circuit Criminal* cases missing defendant data (as this entry is frequently missing), defendant data was identified from any available *Felony* case cross referenced by Cross Reference Type *Grand Jury*. Identifiers queried included the Criminal History Key, Social Security Number, Driver's License Number, and name. The most valid identifier for each case is identified according to the hierarchy:

1. Criminal History Key*
2. Social Security Number
3. Driver's License Number
4. Name with date of birth
5. Name without date of birth
6. Generic Identifier (Expunged, Record Destruction, John Doe)

*The criminal history key is a system generated number that utilizes the other data points indicated in this hierarchy to match defendants across cases as part of the process used by the AOC Department of Records to conduct background checks.

Statistical Analysis Considerations:

- The statistics presented are a snapshot in time as of the date the data was queried: 11/26/2024.
- A case may consist of one or multiple charges. The report's count of cases represents a distinct count of case numbers, regardless of the number of charges associated with the case.
- Counts of cases do not necessarily represent counts of unique individuals.
- In some instances, a criminal history key may not exist for a defendant. The subsequent DUI charges convicted data is calculated using only those in which the criminal history key was able to be matched, and may not accurately reflect the real data.

The Kentucky State Police (KSP) assigns the Kentucky Uniform Crime Reporting Codes (UOR Codes) to criminal offenses in the Commonwealth of Kentucky. The KSP official list of UOR Codes by KRS number and descriptor can be obtained at the KSP's website at www.kentuckystatepolice.org.

The AOC assigns and maintains codes that are used within the Court of Justice Case Management System for statistical and reporting purposes. These codes are used to identify local and city ordinances, as well as codes for general administrative purposes. The AOC official list of UOR Codes with KRS number and descriptor can be obtained at the Court of Justice Website at [Analytics - Kentucky Court of Justice \(kycourts.gov\)](http://Analytics-KentuckyCourtofJustice.kycourts.gov). The AOC UOR Code Listing is for informational purposes only and the information is subject to change, reprogramming, modifications of format, and availability at the direction of the Administrative Office of the Courts (AOC).

A query for data based on specified charges will include each UOR code specified and possible supplemental codes. Supplemental codes (or "ASCF" codes) to any UOR code include: 1) attempt, 2) solicitation, 3) conspiracy, 4) facilitation, 5) complicity, and 6) enhancement. In total, UOR codes contain seven digits. The first six digits are specific to that charge. The seventh digit indicates if there is a supplemental code. A "0" as the seventh digit means that is the primary UOR code and it does not have a supplemental code. If there are supplemental codes, the "0" will change to a 1, 2, 3, 4, 5, or 6 (the numbering corresponds to the list above). An enhancement does not exist on all UOR codes. When a supplemental code does not appear within a dataset, charge(s) did not occur during this period. The presence of "*obs" within the description of a UOR code indicates an obsolete UOR code. However, the code is still present within the KYCourts/CourtNet database and may still be utilized. Not every UOR code included in the query will have charges associated with it in each calendar year

examined. Some cases may contain multiple charges; therefore, charge counts may exceed case counts. The number of cases cannot be inferred as the number of individuals as multiple cases may have the same defendant.
