Statistics Request Overall Description

On February 6, 2023, the Louisville Courier Journal requested from Research and Statistics a report of the number of Forcible Detainer cases disposed from January 1, 2022 through December 31, 2022 including indications of judgments in favor of plaintiffs or defendants.

Courtnet, a database that provides a summary of cases statewide, was queried for Forcible Detainer cases disposed from 1/1/2022 – 12/31/2022 in Jefferson county, including logic to identify the presence in each case of documents related the document codes specified below.

Document Code	Description
JDF	Judgment for defendant in forcible entry & detainer - Not guilty
JPF	Judgment for plaintiff in forcible entry & detainer - Guilty

Statistical Report (23_RS7003)

Statistical Report 23_RS7003 provides a cross-tabulation with a count of the number of Forcible Detainer cases disposed during the requested period grouped by month and forcible detainer outcome. Cases including more than one document or both type of documents are typically cases with multiple defendant parties or errors.

Statistical Analysis Considerations:

- The statistics presented are a snapshot in time as of the date of the query.
- Counts of cases do not equal a count of individuals. An individual may have multiple cases
