GUARDIANSHIP, CONSERVATORSHIP, AND HEALTH CASES FILED FY 2022 BOONE COUNTY

Statistics Request Overall Description

On April 4, 2023, the Boone County Circuit Court Clerk requested from Research & Statistics a report of the number of cases filed in Boone County during Fiscal Year (FY) 2022 related to Involuntary Hospitalization, Casey's Law (Involuntary Treatment for Substance Use Disorder), Tim's Law (Involuntary Outpatient Treatment), or Guardianship.

CourtNet, which provides a summary of court cases statewide, was queried for cases filed in Boone County from 7/1/2021 through 6/30/2022 meeting any of the definitions listed below:

Guardianship / Conservatorship Cases

- Conservatorship Adult: Case Number Type H (Health) with Case Type Code CONSVA (Conservatorship – Adult),
- Conservatorship Juvenile: Case Number Types P (Probate) or C (Civil) with Case Type Code CONSVJ,
- Guardianship Adult: Case Number Type H (Health) with Case Type Code GCADLT (Guardianship – Adult),
- Guardianship Juvenile: Case Number Type P with Case Type Code GCJUV (Guardianship Juvenile),
- Other Petition to Determine if Disabled: Case Number Type H (Health); Case Type Code
 OTH (Other), COM (Commitment), or DIS (Disability, deprecated) and Initiating Document
 Type PDD (Petition to Determine if Disabled).

Health Cases are identified in this report as follows:

- **Involuntary Commitment:** Case Number Type *H* or *J* with Initiating Document Type *PIH* (Petition for Involuntary Hospitalization), *PIT* (Petition for Involuntary Treatment), or *PHDIT* (Petition to Set Hearing to Determine Involuntary Participation of Treatment of Hospitalized Person).
- **Substance Use / Casey's Law:** Case Number Type *H* or *J* with Initiating Document Type *PIHAD* (Verified Petition for 60/360 Day Involuntary Treatment (Substance Use Disorder),
- Outpatient Treatment / Tim's Law: Case Number Type H with Initiating Document Type PCAOT (Petition for Court Ordered Assisted Outpatient Treatment),
- Incompetent to Stand Trial: Case Number Type H with Case Type Code CICP (Criminal Involuntary Commitment Proceeding) and/or Initiating Document PCIC (Petition for Criminal Involuntary Commitment),
- Other / Unknown: Excluding those types indicated below, Case Number H with Case Type

Database	Data Variable	Description		
CourtNet	County	The county in which a case was filed.		
	Case Filing Date	The date the case was filed. Case Filing Date is reported using the Fiscal Year (June 1 st through July 31 st).		
	Case Number Type	A broad identifier of the type of a case. Case Number Type is included within a case's Case Number and may not change after filing.		
	Case Type Code	A more specific indicator of the type of a case. The Case Type of civil cases is generally defined by the Civil Cover Sheet or Electronic Filing. It may be changed after filing.		
	Initiating Document Type	The Document Type Code of the first document filed within a case that represents a petition, complaint, or other document used to initiate a civil case.		
	Cases	A count of distinct court cases.
