Statistics Request Overall Description

On June 20, 2024, Research and Statistics received a request from the Legislative Research Commission for a report of KRS 17.545 charges disposed statewide from calendar year 2019 through calendar year 2023. It was also requested that these charges be broken down by county.

The CourtNet database, which provides a summary of cases statewide, was queried for charges associated with KRS 17.545 that were disposed statewide from CY 2019-2023. A list of all offenses which comprise the data in the report is attached below.

Statistical Table (21_RSX6000 & 21_RSX6002)

Statistical Table 21_RSX6000: Provides a list of charges queried for the report sorted Kentucky Revised Statute, UOR Code, UOR Description, and Charge Level and Class.

Statistical Table (21_RSX6000 & 21_RSX6002)

Statistical Analysis Considerations:

- Statistics represent a snapshot in time, as of the date the data was queried: 7/1/2024.
- A case may consist of one or multiple charges. The report's count of cases represents a distinct count of case numbers, regardless of the number of charges associated with the case.
- Counts of cases do not necessarily represent counts of unique individuals.
- Charges consist of all original and amended charges within a case counted separately.
- Many but not all charges heard in Circuit Court were previously heard in District Court and indicted by grand jury. As such, the sum of charges in District and Circuit Court will count some indicted charges twice and totals from the two jurisdictions are presented separately.

The first six digits are specific to that charge. The seventh digit indicates if there is a supplemental code. A "0" as the seventh digit means that is the primary UOR code and it does not have a supplemental code. If there are supplemental codes, the "0" will change to a 1, 2, 3, 4, 5, or 6 (the numbering corresponds to the list above). An enhancement does not exist on all UOR codes. When a supplemental code does not appear within a dataset, charge(s) did not occur during this period. The presence of "*obs" within the description of a UOR code indicates an obsolete UOR code. However, the code is still present within the KYCourts/CourtNet database and may still be utilized. Not every UOR code included in the query will have charges associated with it in each calendar year examined. Some cases may contain multiple charges; therefore, charge counts may exceed case
