### **Statistics Request Overall Description**

On June 12, 2024, Research and Statistics received a request from the Jefferson County Criminal Justice Commission for a report of Specialty Courts/Drug Court Program participants entering and exiting the Specialty Courts program between January 1, 2014, and December 31, 2023, in Jefferson County, including a snapshot of active Participants as of July 1 for each of the requested years.

The Specialty Courts Management Information System (AOC MIS), the case management and information system used by Specialty Courts, was queried multiple times as described below to collect the requested data:

- For Participants Entering the Adult Drug Court or Veterans Treatment Court Programs, a query for Participants in Jefferson County in which the First Active Status date was between January 1, 2014, and December 31, 2023.
- For Participants <u>Exiting</u> the Adult Drug Court or Veterans Treatment Court Programs, a query for Participants in Jefferson County in which the Exit Status date was between January 1, 2014, and December 31, 2023.
- For the snapshot of Active Participants, a query for each calendar year included in the report for Adult Drug Court or Veterans Treatment Court Participants in Jefferson County having:
  - o A valid First Active Status date on or prior to July 1 of that calendar year, and
  - o Either an Exit Status Date after July 1 of that year, or no Exit Status Date.
    - For Example, for the 2014 snapshot, the query was limited to participants having a First Active Status date equal to or prior to July 1 of 2014, and an Exit Status Date <u>after</u> July 1 of 2014 or no Exit Status Date entered (indicating the Participant is still Active in the Specialty Courts Program).
