# SPECIFIED CHARGES AND CHARGE SERIES DISPOSED CY 2017-2019 AND 2022-2023 JEFFERSON COUNTY CIRCUIT COURT

#### **Statistics Request Overall Description**

On May 10, 2024, Research and Statistics received a request from a member of the news media for an aggregate report detailing dispositions of charges of convicted felon in possession of a handgun or firearm, theft by unlawful taking of a firearm or receiving a stolen firearm, possession of a defaced firearm or defacing a firearm, attempted murder, first degree rape, first and second degree assault, first degree strangulation, first and second degree robbery, and first degree wanton endangerment for calendar years (CY) 2017, 2018, 2019, 2022, and 2023 in Jefferson County Circuit Court. Additionally, it was requested that only base charges be included, with the exception of attempted murder. It was requested that the report contain information detailing the count of cases with at least one conviction of a specified offense within the specified time frame, as well as a count of cases where all specified charges disposed within the specified time frame were dismissed. It was also requested that counts of specified charges that were amended be provided, along with whether they were amended up, amended across, or amended down in severity.

The CourtNet database, which provides a summary of cases statewide, was queried for information surrounding the specified charges filed or disposed in Jefferson County for CYs 2017, 2018, 2019, 2022, and 2023. Information about charge series disposed in that timeframe which started or ended with one of the specified charges was also queried.

#### Statistical Tables (24\_RS6033)

**Statistical Table 24\_RS6033:** Provides 15 pages of data aggregations which display information on the specified charges and charge series disposed in Jefferson County Circuit Court during CYs 2017, 2018, 2019, 2022, and 2023. An amended charge is a change to an indictment, information, complaint, or citation that occurs at any time before a verdict or finding. A charge series consists of an original charge and any subsequent amendments to that charge and the following amended charge(s).

**Page 1:** Provides a cross-tabulation that displays an overall count of specified charges disposed within cases grouped by the minimum disposition date among queried charges within the case, case status (whether a case has any specified convicted charges, if all specified charges in the case were

dismissed, or if the case does not fall into either of those categories), and charge disposition code. Additionally, a count of distinct cases which contain those charges is provided for each grouping.

Charges measured only consist of the charges listed on pages 14 and 15. A case may have convicted or non-dismissed charges which were not queried for this report. Amended charges are excluded from calculations. Charges disposed outside of the requested date range are not represented. A case may have specified charges with differing disposition codes, causing it to appear in a separate row for each distinct disposition code present within the case. Each subtotal displays the quantity of distinct cases and charges for its grouping.

**Page 2:** Provides a cross-tabulation that displays counts of charge series disposed which began with one of the specified charges, grouped by Original Charge UOR & Description, Amended Status, and Final Disposition Year for the charge series. This page is limited to charge series with a final disposition year of CY 2017, 2018, 2019, 2022, or 2023. Charge series which end with a charge bearing a disposition type of pending, amended, or FTA/FTV/AP are excluded as they are incomplete.

**Page 3:** Provides a cross-tabulation that displays counts of charge series disposed which ended with one of the specified charges, grouped by Final Charge UOR & Description, Amended Status, and Final Disposition Year for the charge series. This page is limited to charge series with a final disposition year of CY 2017, 2018, 2019, 2022, or 2023. Charge series which end with a charge bearing a disposition type of pending, amended, or FTA/FTV/AP are excluded as they are incomplete.

**Pages 4-13:** Provide a cross-tabulation that displays counts of charge series disposed which started and/or ended with one of the specified charges, grouped by Original Charge UOR & Description, Amended Level/Class Comparison, Final Charge UOR & Description, Final Series Disposition, and Final Disposition Year for the charge series. This page is limited to charge series with a final disposition year of CY 2017, 2018, 2019, 2022, or 2023. Charge series which end with a charge bearing a disposition type of pending, amended, or FTA/FTV/AP are excluded as they are incomplete.

**Pages 14-15:** Provide a list of specified charges queried for the report sorted by AOC Offense Category, UOR Code, UOR Description, and Charge Level and Class.

- > Statistics represent a snapshot in time, as of the date the data was queried: 6/3/2024.
- A case may consist of one or multiple charges. The report's count of cases represents a distinct count of case numbers, regardless of the number of charges associated with the case.
- Counts of cases do not necessarily represent counts of unique individuals as the same defendant may appear in multiple cases.
- > Charges consist of all original and amended charges within a case counted separately.
- A case may consist of charges which fall under different groupings within the table. In this situation, a case is added to the case count for each grouping that applies to at least one charge within a case. Each subtotal displays the quantity of distinct cases and charges for that grouping, causing subtotals of case counts to add up to a number greater than the actual overall total.
