### Statistics Request Overall Description

On June 10, 2024, Research and Statistics received a request from the Office of the Jefferson County Attorney for an aggregate report of juvenile cases filed during Calendar Years (CY) 2013, 2018, and 2023 that contain at least one charge of receiving stolen property (firearm) (UOR 028020) or possession of a handgun by a minor (UORs 052205, 052206).

CourtNet, which provides a summary of cases statewide, was queried for juvenile cases filed in Jefferson County between 1/1/2013 and 12/31/2023 that contained at least one charge with a UOR of 028020, 052205, or 052206.

### Statistical Tables (24\_RS6038)

**Statistical Table 24\_RS6038:** Provides a cross-tabulation which displays counts of specified charges within J cases filed from 1/1/2013 through 12/31/2023 grouped by UOR Code, ASCF Code, Offense Description, and case filing year. Additionally, a count of distinct cases containing those charges is provided.

#### **Statistical Analysis Considerations:**

- Statistics represent a snapshot in time, as of the date the data was queried: 6/20/2024.
- A case may consist of one or multiple charges. The report's count of cases represents a distinct count of case numbers, regardless of the number of charges associated with the case.
- Counts of cases do not necessarily represent counts of unique individuals, as a defendant may appear in multiple cases.
- A case may consist of charges with differing specified UOR or ASCF codes. In this situation, a case is added to the case count in each row that applies to at least one charge within a case. Each subtotal displays the quantity of distinct cases and charges for that combination of UOR Code, ASCF Code, and Case Filing Year, causing subtotals of case counts to add up to a number greater than the actual overall total.

"2" shows that a solicitation has been charged. "3" shows a conspiracy charge. "4" shows a facilitation charge. "5" shows a complicity charge. "6" shows that the underlying charge has been enhanced.
	KRS	Provides the Kentucky Revised Statute associated with a given UOR Code
	Offense Description	A brief verbal summary of the statutory offense which is the basis for the type of criminal offense with which the defendant has been charged. For Example, UOR Code "0008050" represents the underlying statutory offense of KRS 508.080(1)(B) or, in brief English, "BOMB THREATS". In a related example, UOR Code "0008051" represents the related ASCF code or Inchoate offense of "ATTEMPTED BOMB THREATS".

just-in-time basis. The data is static, representing a particular moment in time. Case counts are not counts of individuals, as some persons may have multiple cases.

The Kentucky State Police (KSP) assigns the Kentucky Uniform Crime Reporting Codes (UOR Codes) to criminal offenses in the Commonwealth of Kentucky. The KSP official list of UOR Codes by KRS number and descriptor can be obtained at the KSP's website at [www.kentuckystatepolice.org](http://www.kentuckystatepolice.org).

The AOC assigns and maintains codes that are used within the Court of Justice Case Management System for statistical and reporting purposes. These codes are used to identify local and city ordinances, as well as codes for general administrative purposes. The AOC official list of UOR Codes with KRS number and descriptor can be obtained at the Court of Justice Website at [courts.ky.gov/aoc/statisticalreports](http://courts.ky.gov/aoc/statisticalreports). The AOC UOR Code Listing is for informational purposes only and the information is subject to change, reprogramming, modifications of format, and availability at the direction of the Administrative Office of the Courts (AOC).

A query for data based on specified charges will include each UOR code specified and possible supplemental codes. Supplemental codes (or "ASCF" codes) to any UOR code include: 1) attempt, 2) solicitation, 3) conspiracy, 4) facilitation, 5) complicity, and 6) enhancement. In total, UOR codes contain seven digits. The first six digits are specific to that charge. The seventh digit indicates if there is a supplemental code. A "0" as the seventh digit means that is the primary UOR code and it does not have a supplemental code. If there are supplemental codes, the "0" will change to a 1, 2, 3, 4, 5, or 6 (the numbering corresponds to the list above). An enhancement does not exist on all UOR codes. When a supplemental code does not appear within a dataset, charge(s) did not occur during this period. The presence of "\*obs" within the description of a UOR code indicates an obsolete UOR code. However, the code is still present within the KYCourts/CourtNet database and may still be utilized. Not every UOR code included in the query will have charges associated with it in each calendar year examined. Some cases may contain multiple charges; therefore, charge counts may exceed case counts. The number of cases cannot be inferred as the number of individuals as multiple cases may have the same defendant.
