### Statistics Request Overall Description

On March 9, 2023, the Office of the Jefferson County Attorney, requested from Research and Statistics a report of the number of Tim's Law documents that have been filed within cases from 1/1/2019 to present and includes totals for Boone County, Jefferson County, and Kenton County, in addition to the combined total for all other counties statewide.

CourtNet, which provides a summary of cases statewide, was queried for the number of Tim's Law documents filed statewide within mental health cases (H-) from January 1, 2019, through April 4, 2023.

The document codes queried for this report include:
