# **Statistical Analysis Considerations**<sup>1</sup>

- Historical Reports display court case statistical information obtained from queries of CourtNet, the summary of Kentucky civil and criminal trial court cases statewide. Court statistics are presented by county level and statewide. The data is reported per calendar years. The database is not updated in real-time. Court information is not instantaneously updated in the databases. Updates can vary from within an hour to several times a day.
- 2. The data reported are the court cases filed or closed in a given county during a particular calendar year(s). Trial court jurisdictions include Circuit, Family and District Courts. Overall, court cases involve civil matters, family and children issues, criminal offenses and other violations. Cases filed in Circuit Court may be indicted or amended up from district court, so a case could be counted once in both venues.
- 3. CourtNet stores the following case information, for example:
  - Criminal cases include Case Type, Charges, Sentences, Documents, Party Information, and Motions and Outcomes.
  - Civil cases consist of Case Type, Documents, Party Information, and Motions and Outcomes.
- 4. The civil and criminal case counts are calculated using the case's unique number. The case count is distinct, and is counted once, regardless of the number of parties, petitions, orders, and /or charges filed/disposed within the respective case. For subtotal and total counts of cases filed or closed, frequency counts will always be distinct counts based on the case number.
- 5. A dash (-) within the Historical Reports is the same as zero (0).
- 6. Averages within the historical report are calculated as Total number of Cases with a Specified Case Type divided by number of calendar years.
- 7. Civil and criminal case types associated with each court jurisdiction.
  - The Circuit court case types are classified as Administrative Board Appeals, Adoption/Termination, Appeal Civil, Appeal Criminal, Circuit Criminal, Civil Suits, Domestic and Family, Other Civil, Others, probate, and URESA (Uniform Reciprocal Enforcement Act).
  - The Family Court case types include the categories Adoption/Termination, Domestic and Family, Juvenile, Others, and URESA.
  - District Court case types are defined as Civil, Disability and Health, Domestic Violence, Felony, Juvenile, Misdemeanor, Others, Probate, Small Claims, Traffic, and URESA.
- 8. Criminal cases are most often defined as Appeal Criminal, Circuit Criminal, Felony, Misdemeanor, and Traffic case types. Juvenile Delinquency cases are also defined as criminal cases.
- 9. Administrative Board Appeals, Adoption/Termination, Appeal Civil, Civil Suits, Domestic and Family, Other Civil, Probate, Civil, Disability and Health, Domestic Violence, Felony, and URESA (Uniform Reciprocal Enforcement Act) are classified as civil cases, except Other, which may include criminal cases that do not fall in the other criminal case types.

- 10. Case counts are not the same as a count of individuals. A court party may have multiple cases, and, in turn, a case may have multiple parties. For example, a criminal defendant may have a criminal case filed on January 29, 2014 in County Y and another criminal case filed in the same county on August 12, 2014. For calendar year 2014 the statistical count, in this incident, would equal 2 cases and 1 defendant.
- 11. Counts of cases and charges (DUI), documents (such as Emergency Protective Orders), or violations (such as Violation of KY EPO/DVO) may not equal, as a case may have multiple charges, documents, or violations. A case may consist of one or multiple requested charges. The report represent distinct case counts, counting the case only once, regardless of the number of charges associated with the case. The counts for charges at times will be greater than number of cases, as a case could have multiple charges. The report contains the distinct count of cases. That is, regardless of the number of charges within the case, the case is counted only once.
- 12. Charges consist of all original and amended charges. The analysis includes the ASFC code when determining the charge count (0-No ASCF, 1-Attempt, 2-Solicitation, 3-Conspiracy, 4-Facilitation, 5-Complicity, and 6-Enhancement; and these codes are indicated by the last digit noted on a given UOR code).
- 13. Cases may/may not be filed and closed during the same calendar year (January 1 to December 31). When comparing case filed with case closed during the same timeframe, do not assume the separate case counts are for the exact same cases or a one to one match can be made. For example, a case may be filed on November 1, 2014 and closed (judge has disposed the case) on March 1, 2015. The case filed count would be counted as 1 case filing during calendar year 2014. While the closed case would be counted 1 case closing during calendar year 2015.

The Kentucky State Police (KSP) assigns the Kentucky Uniform Crime Reporting Codes (UOR Codes) to criminal offenses in the Commonwealth of Kentucky. The KSP official list of UOR Codes by KRS number and descriptor can be obtained at the KSP's website at www.kentuckystatepolice.org.

The AOC assigns and maintains codes that are used within the Court of Justice Case Management System for statistical and reporting purposes. These codes are used to identify local and city ordinances, as well as codes for general administrative purposes. The AOC official list of UOR Codes with KRS number and descriptor can be obtained at the Court of Justice Website at <a href="courts.ky.gov/aoc/statisticalreports">courts.ky.gov/aoc/statisticalreports</a>. The AOC UOR Code Listing is for informational purposes only and the information is subject to change, reprogramming, modifications of format, and availability at the direction of the Administrative Office of the Courts (AOC).

A query for data based on specified charges will include each UOR code specified and possible supplemental codes. Supplemental codes (or "ASCF" codes) to any UOR code include: 1) attempt, 2) solicitation, 3) conspiracy, 4) facilitation, 5) complicity, and 6) enhancement. In total, UOR codes contain seven digits. The first six digits are specific to that charge. The seventh digit indicates if there is a supplemental code. A "0" as the seventh digit means that is the primary UOR code and it does not have a supplemental code. If there are supplemental codes, the "0" will change to a 1, 2, 3, 4, 5, or 6 (the numbering corresponds to the list above). An enhancement does not exist on all UOR codes. When a supplemental code does not appear within a dataset, charge(s) did not occur during this period. The presence of "\*obs" within the description of a UOR code indicates an obsolete UOR code. However, the code is still present within the KYCourts/CourtNet database and may still be utilized. Not every UOR code included in the query will have charges associated with it in each calendar year examined. Some cases may contain multiple charges; therefore, charge counts may exceed case counts. The number of cases cannot be inferred as the number of individuals as multiple cases may have the same defendant.
