In light of changing direction from the Kentucky Supreme Court pursuant to Kentucky Supreme Court Amended Order 2021-27; and

WHEREAS, the prior General Order for this jurisdiction entered May 28, 2020 is thereby outdated; and

WHEREAS, the foregoing circumstances make it appropriate and necessary to modify the prior General Order for this jurisdiction:

IT IS HEREBY ORDERED FOR THE BULLITT CIRCUIT/DISTRICT COURT ALL DIVISIONS beginning October 18, 2021, the **GENERAL ORDER SUPPLEMENTING KENTUCKY SUPREME COURT ORDERS 2020-39/40 IN RESPONSE TO THE COVID-19 EMERGENCY** be and is set aside and held for naught. Each Judge shall, for her or his division, determine and publish rules for their respective Court with regard to whether proceedings such as dockets, hearings, trials, etc. shall be conducted in person, remotely, or in some hybrid form and address any procedural modifications which may be appropriate in consideration of same.
