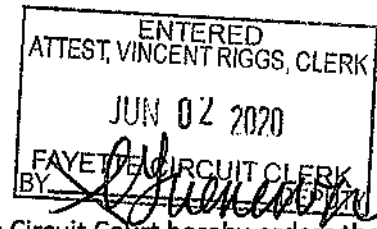


Fayette Circuit Court
General Order
June 1, 2020



Pursuant to the Kentucky Supreme Court Order 2020 - 39, 40, 43, and 44, the Fayette Circuit Court hereby orders the following:

CIVIL COURT

- All Civil Trials are cancelled until August 1st, per KY Supreme Court Order 2020-40.
- All Civil Pre-trials shall proceed by telephone or by Zoom. Please contact each Division.
- All motions should be noticed for Motion Hours, then the Court will schedule most civil motions by Zoom at a separate time.

CRIMINAL COURT

- All Criminal Trials are cancelled until August 1st, per KY Supreme Court Order 2020-40.
- All In-Custody Video Arraignments shall be held on Thursdays by ZOOM Only. Out of Custody Arraignments can be held by ZOOM or In-Person on Thursdays or during the Division's Motion Hour.
- All Thursday Criminal Pre-trials shall be cancelled, and they shall proceed telephonically or electronically until August 1st.

JURY SERVICE

- All Civil and Criminal Jury Trials are suspended until after August 1, 2020.
- The Fayette Circuit Court will impanel a Grand Jury for June 2020 and July 2020.

COURT ENTRY and ATTENDANCE

Courtroom attendance shall be limited to attorneys, parties, witnesses and other necessary persons as determined by the Judge. All individuals are advised to wear a mask and adhere to social distancing guidance provided inside the courthouse. In no event may attendance exceed 33% of the Courtroom's capacity pursuant to the Kentucky Supreme Court's Orders 2020 - 39, 40, 43 and 44.
