It is estimated that more than two million arrests in the United States each year involve people with Serious Mental Illnesses – half of which are homeless at the time of their arrest. As a result, untrained and unprepared stakeholders in the criminal justice system have been forced to navigate an increasingly scarce system of care for people with mental illnesses. Jails have become places where a disproportionate number of people with Serious Mental illness spend significant amounts of time; their ties to the community severed, their treatment needs unmet, and their illnesses made worse. Judge Leifman will discuss his journey into the mental health system, the legal and medical history that led to America's mental health crisis, and the essential elements necessary to create an effective system of care that will transform the mental health and criminal justice systems, making jail the last option for people with Serious Mental Illness and not the first.

Share your experiences working with justice-involved individuals experiencing behavioral health needs with the Bureau of Justice Assistance (BJA). Session participants will be asked to discuss barriers, gaps, needs, and promising approaches. Participants will also learn about BJA's priorities and relevant programs for communities as they work with justice-involved persons with behavioral health needs. Summit attendees from all disciplines are encouraged to attend.

Session B – The Judge as a Change Agent: Developing an Effective Local Criminal Justice/Mental Health Community (Breathitt)

This session will review changes within the American judicial system and discuss how these changes require judges to adapt their approach towards defendants with serious mental illness and substance use disorders. Additionally, attendees will learn ways to develop diversion programs that will significantly improve outcomes for people with mental illnesses and co-occurring disorders, thereby improving public safety and saving critical tax dollars.

By breaking down silos, we can begin to identify the links between interpersonal abuse, animal abuse, and substance misuse. These behaviors impinge on the mental health of everyone within the household experiencing them. Mental health issues, substance use, and traumatic events from childhood to senior adulthood are possible for anyone. Unfortunately, in addition to these concerns, many veterans experience life-altering events, ranging from exposure during deployments for disaster relief to full-scale war that heightens the need for additional support. There is also difficulty in convincing a veteran to proactively seek and participate in services. This session will explore ways to promote awareness and enhance support for veterans.

#### Session H – Student Mental Health Initiative (Jones)

Student mental health has been a growing problem even before the pandemic. This session will provide an overview of the Student Mental Health Initiative and the efforts underway to improve student mental health in Kentucky schools.

Kentucky has operated in accordance with the national system of care framework for over 30 years. In this session, presenters will describe Kentucky's operationalization of the philosophy, infrastructure, services, and supports within the framework. Programs, services, and support available through the public behavioral health safety net will be highlighted along with accompanying resources. Presenters will facilitate a brief interactive discussion of the behavioral health crisis and the critical importance of ensuring collaborative responses adhere to the system of care framework. Kentucky's strategies to mitigate the crisis will be shared.

Session K – Unshame KY (Laffoon)

Kentuckians have the power to end the stigma associated with opioid use disorder (OUD) and reverse the addiction crisis. UNSHAME Kentucky is a public health campaign aimed to reduce the addiction-related stigma held by Kentuckians across the state. The intervention has three main objectives: increase knowledge about opioid use disorder (OUD) and that recovery is not only possible, but probable with proper support; improve attitudes toward those living with and/or in recovery from OUD; and develop Kentuckians' understanding of the disease so people can better support loved ones with OUD.

Session L – Mental Health Challenges in the Judicial System: Judge's Role in Treatment Success (Carroll Ford)

Improving mental health responses in your community requires leadership, a shared vision, and collaboration among multidisciplinary stakeholders. This session will explore the Sequential Intercept Model and provide information on Kentucky's efforts in identifying resources and opportunities to improve local responses to individuals experiencing mental illness, substance use disorders, and/or intellectual and developmental disabilities. This session provides a roadmap for working together to prioritize efforts that focus on early identification, eliminating barriers, providing alternate diversion opportunities, and creating meaningful change.

Social determinants have complex impacts on health and mental health. This session will identify root causes of inequity as drivers of mental health, review the intersectionality of trauma and substance use and mental health outcomes, and explore actionable recommendations that enable equitable mental health access and holistic wraparound services for disenfranchised, underserved and vulnerable populations.

#### Session B - Transforming Families: Implementing Family Recovery Courts (Breathitt)

Learn how Kentucky has successfully developed and implemented family recovery courts for families affected by substance use disorder. This model program began in Jefferson County and has been replicated in Clay and Lincoln counties with plans for future expansion.

Intentionally lifting up youth and young adult voices is especially pertinent to recognizing how systems can impact the mental health for those in our communities. Hear perspectives from young adults who have been directly impacted by the juvenile justice or child welfare systems to understand how mental health can be impacted by the courts in many ways, hear how trauma can impact the way we respond to situations, and discover ways the court system can better serve young people and their families.

## Session D – The Fundamentals of Assisted Outpatient Treatment (AOT) and Kentucky's Expansion of Tim's Law (Segell)

Assisted outpatient treatment (AOT) provides community-based mental health treatment under civil court commitment to adults with serious mental illness. AOT participation improves voluntary treatment adherence and greater engagement in recovery. Enacted in 2017 as "Tim's Law," AOT is funded through a SAMHSA grant to serve individuals discharged from Central State Hospital (Louisville) and Western State Hospital (Hopkinsville). Additional state funding provides AOT to incarcerated individuals in Jefferson County and in the Eastern State Hospital (Lexington) and Appalachian Regional Hospital (southeastern Kentucky) regions. It is hoped that the General Assembly will provide full funding for statewide AOT implementation in 2024.

## Session E – California CalAIM 1115 Demonstration: Justice-Involved Reentry Initiative (French)

California will discuss its approach to designing, securing federal approval, and preparing to implement the CalAIM Justice-Involved Initiative, a first-in-the-nation Medicaid section 1115 demonstration to cover a targeted set of Medicaid services to youth and adults in state prisons, county jails, and youth correctional facilities for up to 90 days prior to release. The goals of the CalAIM Justice-Involved initiative include increasing and continuing Medi-Cal coverage; improving coordination and communication among correctional systems, Medicaid systems, and community-based providers; and providing appropriate health care interventions at earlier opportunities.

### Session F – Kentucky Office of Vocational Rehabilitation: An Overview of Consumer Services (Stopher)

#### David Trimble, Operational Support Troop Major, Kentucky State Police

Law enforcement is the first, and often only, contact an individual has with the criminal justice system. An agency's ability to develop programs, policies and procedures that recognize, support, and assist in addressing the special needs of crime victims, individuals struggling with a substance use disorder, as well as adults and children involved in a traumatic incident is an integral part of service to the community. The Kentucky State Police created its Victim Advocacy and Support Services to assist in meeting the needs of crime victims and those involved in traumatic events.

Session I – Exploring the Prism: When Intellectual Disability, Mental Health, and the Judicial System Intersect (Sampson)

#### Speaker: Dr. Brandy Koch, PhD, Director of Psychology, Hazelwood and Bingham Garden

This session will provide an overview of intellectual disability (ID) and mental health conditions, discuss disparities in mental health care for individuals with intellectual disabilities and identify when more specialized care is needed. This session will also discuss the intersection of ID and the judicial system, a brief overview of the legal process for treatment of individuals with ID (KRS 202B) and what Intermediate Care Facilities (ICF) for individuals with ID do and how they help.

#### Session J – Autism 101: How to Support Individuals with Autism (Wilkinson)

#### Speaker: Mary Helen Richer, CEO, Autism Connections

In this session, attendees will learn about autism and the typical characteristics associated with the diagnosis. The session will also offer tips and strategies for first responders, state and county officials, and mental health professionals to better interact and support individuals with autism.

#### Session K - Any Positive Change: Harm Reduction is Public Health (Laffoon)

This session will explore evidence-based harm reduction measures such as naloxone distribution, syringe access programs, and linkage to evidence-based, HIV, hepatitis, and substance use disorder treatment.

#### Session L – Legal Implications of Sexting and Screen Addiction (Carroll Ford)

This session will provide an overview on the signs and symptoms of screen addiction (internet gaming disorder and compulsive sexual behavior disorder) with a focus on attachment, the legal implications of behaviors like compulsive pornography use and sexting, and a brief description of treatment methods related to these issues.

A fatality or near fatality of a child often impacts the wider community, with everyone left wondering what could have been done differently to prevent the untimely death or near death of a child. Judges Melissa Murphy and Libby Messer investigate what can be done institutionally to handle abuse and neglect cases where child fatality and near fatality occur, and how mental health and substance use may factor into the situation.

## Session B – Breaking Down Barriers: Reentry and Recovery Housing in Kentucky (Breathitt)

Working in the justice system carries inherent challenges for well-being and increases the risk of staff burnout, secondary traumatic stress, and moral distress. Understanding and addressing these risks are essential for successful workforce recruitment and retention, and maintenance of high-quality programs and services. This session explores the effects of this cumulative toll and provides strategies and resources for individuals and organizations in the justice system to promote awareness, reduce risk and mitigate impact.

It is a transformative method that focuses on building motivation, coping with urges, managing behaviors, as well as providing the resources necessary for individuals to live a balanced life that includes positive self-regard and willingness to change.


Please note that Mutual Aide meetings will be held in the Beckham Room, located on the 3<sup>rd</sup> floor of the East Tower.

#### Overdose Education and Naloxone Distribution Training

Offered by the Department for Public Health's Harm Reduction Team, this training will teach attendees how to recognize the signs and symptoms of an opioid overdose and how to administer the opioid overdose reversal drug Naloxone (brand name NARCAN) in the event of an overdose. In addition, attendees will acquire a foundational understanding of the opioid crisis. Attendees who complete this training will receive an Overdose Reversal Kit. Overdose Education and Naloxone Distribution Trainings will be offered between noon and 6 p.m. on May 31 and June 1 in the McCreary room, located on the 3<sup>rd</sup> Floor, East Tower.


# Galt House Map

### East Tower





# **Exhibitor Hall**

Thank you to each exhibitor that has taken the time to share your work at this Summit. We appreciate all that you do throughout the state to make Kentucky a better place to live for those experiencing mental illness, substance use disorder, and/or intellectual and developmental disabilities. Collaboration is key in ushering forth a recovery-oriented system of care in the Commonwealth, and each of the exhibitors here at the Summit plays a special role in that.

### Exhibitor Descriptions

<u>Addiction Recovery Care (ARC)</u>: Addiction Recovery Care (ARC) is a leader in helping people find long-term recovery from substance use disorder and operates a network of over 30+ residential and outpatient treatment centers across Kentucky. ARC's Crisis to Career model of care combines clinical treatment with life skills and job training to ensure clients' success even after they've completed their program at ARC. Since opening its first residential treatment center in 2010, ARC has grown to employ more than 800 people across the state and is continuing to pursue opportunities that will help bring its mission to others impacted by addiction.

Administrative Office of the Courts, Family and Juvenile Services: The Department of Family and Juvenile Services (FJS) is dedicated to improving the lives of children and families involved in Kentucky's juvenile justice and child welfare systems. FJS provides direct services to children and families and offers education, programming, and technical support to the judges and court personnel working with juvenile and family law cases. FJS oversees two programs required by statute to provide services statewide, the Court Designated Worker Program and the Citizen Foster Care Review Board, and administers grants designed to improve family courts, support family and juvenile law initiatives, improve responses in domestic violence, and train judicial personnel in behavioral health best practices.

Administrative Office of the Courts, Human Resources: The Kentucky Administrative Office of the Courts Department of Human Resources provides comprehensive personnel services to the Kentucky Court of Justice. Currently, the department processes personnel actions, payroll, health, life, and retirement benefits for all Kentucky Court of Justice officials and employees. In addition to personnel services, the AOC human resources department also provides support in the areas of hiring, coaching, employee relations, and continued education for staff regarding employee rights and responsibilities.

<u>Administrative Office of the Courts, Kentucky Citizen Foster Care Review Board</u>: The Kentucky Citizen Foster Care Review Board (CFCRB) program is a mandated state-wide program of court-appointed volunteers making a difference in the lives of children in out-of-home care. These volunteers review children who have been removed from their homes

due to dependency, neglect, and abuse, and provide recommendations to the court as to the children's well-being, helping to ensure that safe, timely permanency remains the central objective of the courts and the Cabinet for Health and Family Services. In FY 2022, 755 dedicated CFCRB volunteers conducted 21,376 reviews of 12,947 children placed in out-of-home care.

<u>Administrative Office of the Courts, Pretrial Services</u>: The Department of Pretrial Services oversees a statewide program based on the premise that defendants are presumed innocent until proven guilty and are entitled to reasonable bail. Supported by federal and state constitutions, Pretrial Services operates in all 120 Kentucky counties and provides services 24 hours a day, seven days a week. Pretrial Specialists are mandated by Supreme Court rule to conduct an interview and assessment within 12 hours of arrest on individuals arrested on bailable offenses. If a defendant does not qualify for administrative release, pretrial employees then present the findings to a judge, who makes the decision about pretrial release.

<u>Administrative Office of the Courts, Specialty Courts</u>: Kentucky Specialty Courts offer an array of opportunities for justice-involved individuals with substance use disorder, mental health diagnoses, and/or service history in the United States military to receive treatment and recovery support services in lieu of jail or prison. We accomplish this through a combination of judicial oversight and case management services through Drug Courts, Mental Health Courts, and Veterans Treatment Courts, collectively known as "Specialty Courts." More than a decade of research indicates that Specialty Courts reduce crime by lowering recidivism, improving substance use disorder treatment outcomes, and reuniting families while also producing measurable cost benefits to communities.

<u>Aetna Better Health of Kentucky</u>: Aetna Better Health of Kentucky is part of Aetna, one of the nation's leading health care providers and part of the CVS Health family. Aetna Better Health has over 30 years of experience serving Medicaid populations including children, adults and people with disabilities or other serious health conditions. Aetna brings national experience to each community.

<u>Alkermes</u>: Alkermes is focused on developing innovative medicines to address the unmet needs of people living with serious mental illness, addiction and cancer. As a fully-integrated global biopharmaceutical company, Alkermes applies its scientific expertise and proprietary technologies to develop products that are designed to make a meaningful difference in the way people manage their diseases. Alkermes hopes to bring this information and knowledge to the criminal justice system and those working with justice-involved individuals.

Appalachian Wellness, LLC: Appalachian Wellness, LLC is a proud integrated health services organization that has served Eastern Kentucky since 2016. Its compassionate team provides a wide array of services, including Behavioral Health Services like Psychiatric Care, Intensive Outpatient Programs, Anger Management Programs, Parenting Programs, Psychological Evaluations, Individual/Family/Couples Psychotherapy, Group Therapy, Casey's Law Evaluations, and Forensic Assessments. Appalachian Wellness also provides Substance Use Treatment which includes Medication Assisted Treatment (Suboxone Vivitrol, and Sublocade), Case Management, Community Services, Peer Support Services, and Transportation Services. Last, Appalachian Wellness's Primary Care Services include Preventative primary care services, ongoing individualized healthcare treatment for chronic and acute health needs, and Hepatitis C treatment.

<u>Athena Women's Behavioral Health</u>: Athena Women's Behavioral Health (AWBH) supports women. AWBH is a BHSO and AODE organization focusing on providing mental health services to the young women of Madison County and surrounding counties. AWBH offers services for females between the ages of 13-years-old to 30-years old, providing mental health services in an all-inclusive private setting that considers each client's needs. Services include Individual and group therapy, Intensive Outpatient Therapy, Family Peer Support, Medication Management, Nurturing Parenting Classes, Anger Management classes, Healthy Relationship classes, and Batterers Intervention programs. LBGTQ+ parenting and support groups are also offered.

**Behavioral Health Group**: Behavioral Health Group is the largest Opioid Treatment Program not only in the state of Kentucky, but across the Nation. At Behavioral Health Group everyone is met with hope, respect and a caring approach, with an empathetic response to where that individual is on their recovery journey. Behavioral Health Group creates individualized treatment planning with a holistic approach, offering several therapeutic options and community partnerships to ensure goals are achievable. Utilization of evidence-based and personalized methodology enhances the opportunity to work within the community and partner with other organizations to restore lives and strengthen families.

**BrightView Health**: BrightView is a comprehensive addiction treatment center, providing outpatient treatment and care for patients who are battling drug or alcohol addiction. Brightview's evidence-based approach incorporates medication for addiction treatment (MAT), along with individual counseling, group therapy, social service support, and work on co-occurring disorders. Brightview's team takes an individualized approach with each patient, meeting them wherever they are in the recovery process. Brightview wants its intensive outpatient services to be available to all who need them, accepting Medicaid and Medicare along with most forms of private health insurance.

Department for Behavioral Health, Developmental and Intellectual Disabilities: The Department for Behavioral Health, Developmental and Intellectual Disabilities (DBHDID), within the Kentucky Cabinet for Health and Family Services, is responsible for supporting the development, administration and implementation of statewide programming for prevention, treatment and recovery from behavioral health disorders across the lifespan. In partnership with state agencies, community organizations and behavioral health and developmental and intellectual disability service providers, DBHDID works to expand access, availability, acceptability and quality of evidence-based services and supports. DBHDID's mission is to promote health and well-being by facilitating recovery for people whose lives have been affected by mental illness and substance use; supporting people with intellectual or other developmental disabilities; and building resilience for all.

<u>Goodwill Industries of Kentucky</u>: Founded in 1923, Goodwill Industries of Kentucky is a 501(c)(3) nonprofit organization. It has 1,800 dedicated employees driven by the mission to serve Kentuckians who are recovering from addiction, reentering society from incarceration, lacking education or transportation, living unhoused or homeless, surviving chronic poverty, or living with an intellectual or physical disability. Through the power of work, Goodwill gives a hand up to these individuals, helping them achieve and maintain employment to gain a better quality of life.

**HEALing Communities Study, University of Kentucky**: Funded by the National Institute on Drug Abuse, the HEALing Communities Study (HCS) represents the largest grant ever received by the University of Kentucky. Over the past 3 years, HCS has engaged 16 Kentucky communities in testing the impact of implementing an integrated set of evidence-based

practices across justice, healthcare, behavioral health, and other community-based settings to reduce opioid overdose deaths. HCS has partnered with Kentucky county jails, specialty courts, probation and parole offices, pretrial services, and other justice-related agencies to embed overdose education and naloxone distribution as well as linkage to medication treatment for opioid use disorder provided by peer support specialists and care navigators in their standard operating procedures.

Holon Health, Inc.: Holon Health pairs a bio-psych-social care team with a proprietary digital therapeutics to help people with substance use disorder fill gaps in care and remove social obstacles that limit their ability to engage in treatment. Holon Health combines timely healthcare appointments, delivered face-to-face via telehealth, with a digital companion mobile app to offer around-the-clock support and motivation. Holon Health's collaborative care helps clients create a plan that addresses gaps in healthcare, transportation, education, income, housing, relapse prevention, behavior change, and other social support issues. This plan is paired with a digital companion mobile app that promotes engagement with the care plan through motivational incentives, psycho-education, and a dose of cognitive behavioral therapy.

**Indivior**: Indivior is a global pharmaceutical company working to help change patients' lives by developing medicines to treat substance use disorders (SUD) and serious mental illnesses. Indivior's vision is that all patients around the world will have access to evidence-based treatment for the chronic conditions and co-occurring disorders of SUD. Building on its global portfolio of OUD treatments, Indivior has a pipeline of product candidates designed to both expand on its heritage in this category and potentially address other chronic conditions and co-occurring disorders of SUD, including alcohol use disorder and cannabis use disorder. Headquartered in the United States in Richmond, VA, Indivior employs more than 900 individuals globally and its portfolio of products is available in over 40 countries worldwide.

**Kentucky Hospital Association**: The Kentucky Hospital Association (KHA) is a nonprofit organization representing the hospitals and health care systems of Kentucky. Established in 1929 and headquartered in Louisville, KHA serves as an advocate for the health care industry, working to ensure that policymakers and the public understand the important role that hospitals play not only in delivering high quality health care, but also in the state's economy and overall well-being of Kentuckians. In addition to advocacy and representation, KHA provides a range of services to its members, including education and training programs, data analysis and benchmarking, and networking opportunities. The organization also provides support and resources for hospital administrators and staff, helping them to navigate the complex regulatory and financial environment of the health care industry.

<u>Kentucky Lawyer Assistance Program</u>: The Kentucky Lawyer Assistance Program (KYLAP) was created as an agency of the Kentucky Supreme Court and is a program of the Kentucky Bar Association that offers help to lawyers, law students, and judges who are struggling with mental health issues, such as depression, alcoholism and drug addiction, stress, compulsive gambling, or any other condition that may adversely impact the individual's personal or professional life. KYLAP's mission and purpose is to address impairment issues within the Kentucky legal community and offer confidential assistance to those who are affected.

**<u>Kentucky Protection and Advocacy</u>**: Protection and Advocacy works to improve the lives of people with disabilities by guarding against abuse, advocating for basic rights, and ensuring access and accountability in health care, education,

employment, housing, transportation, voting, juvenile justice and criminal justice systems. Protection and Advocacy provides no-cost civil legal representation to individuals with disabilities, including those with serious mental illness and intellectual/developmental disabilities, whose rights have been violated due to disability. Protection and Advocacy also collaborates extensively with community, civic and governmental organizations to enhance the lives of Kentuckians with disabilities.

<u>Kentucky River Community Care</u>: Kentucky River Community Care (KRCC) has a well-regarded addiction and behavioral health services division. KRCC is a leader within the state known for stellar teen drop-in centers, recovery housing, and homeless shelters which provide housing and behavioral health treatment. KRCC partners with the Courts and police departments to develop programs that meet the needs of the community and are committed to exploring new connections and more effective interventions to work with justice-involved individuals. KRCC has demonstrated successful outcomes for tenants, adults, children and youth and has received requests from community partners, Drug Court and Judicial Systems for expansions in several areas. KRCC strives to improve the continuum of interventions with all populations within our communities.

**Lincoln Trail Behavioral Health System**: Lincoln Trail Behavioral Health System specializes in providing psychiatric, substance use and co-occurring treatment for adolescents and adults across the state of Kentucky. Lincoln Trail has a specialty unit for active duty military, veterans and first responders struggling with mental health or substance use issues. Lincoln Trail is the only facility in the state of KY providing a specialized trauma unit for females ages 9-17.

<u>Mental Health America of Kentucky</u>: Mental Health America of Kentucky (MHAKY) aims to establish a statewide audience and increase prevention work. MHAKY is involved in decriminalization advocacy and offers mental health resources to those involved in the justice system and working within it. MHAKY offers mental health education and prevention resources in the form of webinars, trainings, screenings, toolkits, and more, focusing on an array of mental health topics including suicide prevention, early serious mental illness, first episode psychosis, BIPOC mental health, adult and youth mental health first aid, and more. MHAKY works closely with partnering community agencies and organizations to reach all Kentuckians.

<u>New Vista</u>: New Vista is one of only a few Certified Community Behavioral Health Clinics in the state of Kentucky. It provides comprehensive care for those that need it most. Annually New Vista provides \$700,000 in free clinical services, maintains a staff of 200 licensed therapists, psychiatrists, and nurses, serves the community with 52 program locations, and takes more than 75,000 phone calls on our 24-Hour Helpline along with managing 988 services.

**Operation 2 Save Lives and QRT National**: The Operation's core foundational work and advocacy is in engaging the ten Kentucky Cabinet of Health and KORE QRT teams across their jurisdictions of more than thirty KY counties. Initially, its focus was to address the opioid overdose crisis, but it has expanded to integrate vulnerable populations struggling with mental health disorders, drug-exposed children, and children witnessing trauma, while engaging family members and loved ones of those struggling with these disorders. An integral part of all the Operation's national deflection work is engaging directly with the judicial agencies and stakeholders, working collaboratively to "deflect" at-risk persons to treatment, resources, and care. The Operation's team is continuously educating and learning from the field how to better serve our partners, sites, and teams.

**Operation UNITE/KY HELP Statewide Call Center**: Operation UNITE staffs the statewide call center, a toll-free line providing personalized, compassionate assistance and resources for Kentuckians in all 120 counties seeking help for substance use disorder and offering support to their families. Individuals, professionals or loved ones seeking treatment for themselves or others can call 1-8338-KYHELP (1-833-859-4357) toll free and speak with a specialist about available services most relevant to their needs. The line is staffed Monday-Friday from 8:30 a.m. to 10 p.m. ET and on Saturday and Sunday from 8:30 a.m. to 5:30 p.m. ET.

**<u>Ramsey-Estep/Re-group</u>**: Ramey-Estep/Re-group is a mental health and substance use disorder nonprofit organization located in Northeastern and Northern Kentucky, providing outpatient SUD and mental health services, adult SUD residential services, school-based services, KSTEP services and treatment foster care. Ramsey-Estep has grown significantly over the past five years and works closely with local court officials and representatives. As an organization committed to offering recovery and mental health services that are needed, evidence-based and that measure up to any provider in the nation, Ramsey-Estep will be able to connect with other individuals who have the same drive and passion for helping those in Kentucky.

**<u>RiverValley Behavioral Health</u>**: RiverValley Behavioral Health is Kentucky's designated regional Community Mental Health Center. RiverValley offers a full range of behavioral health services and substance use treatment to adults, children, adolescents, and their families, as well as services catered to individuals with intellectual disabilities. RiverValley's services are individualized, trauma-informed, evidence-based, and specifically developed to meet the unique, growing behavioral health needs of each community. RiverValley provides services in Daviess, Henderson, Ohio, Union, McLean, Hancock, and Webster counties. RiverValley's staff provides hope and a nurturing, stabilizing force to the communities served through a full continuum of care.

Seven Counties Services, Bellewood and Brooklawn: Seven Counties Services is a Community Mental Health Center that offers a full range of mental and behavioral health services, substance use treatment, and intellectual and developmental disabilities services in a seven-county region in Kentucky. Counties served include Jefferson, Oldham, Bullitt, Shelby, Spencer, Trimble, and Henry. Since 1978, Seven Counties Services has delivered innovative, individualized, and compassionate community-based treatment, support and services for persons with behavioral health needs including people with mental illness, children with emotional and behavioral disorders, individuals with developmental or intellectual disabilities, and adults and adolescents with addiction and substance use disorders. In the past year alone, Seven Counties Services has provided services to over 26,000 individuals including 65,000 crisis response calls and 209,000 telehealth services.

<u>Shepherd's House, Inc.</u>: The Shepherd's House provides addiction treatment programs across five counties in Kentucky. Programs include intensive outpatient, long-term recovery housing for men and women; contracts with KYDOC to deliver SAP/SOAR programming to justice-impacted men and women in Grant, Shelby and Boyle Co. jails; A Recovery Community Center in partnership with a grant from the KY Opioid Response Effort (KORE-CHGS); and a Community Impact Treatment Program in partnership with the Joint Jail Commission of Boyle/Mercer County (a jail diversion program). Across all programs, the Shepherd's House provides addiction treatment services to over 350 men and women daily. <u>Spero Health</u>: Spero Health is Kentucky's largest treatment provider of addiction services. Using an integrated approach of Behavioral Health Therapy, Targeted Case Management and Medication Assisted Treatment, Spero Health treats approximately 7,300 patients a month across 32 KY locations. Spero often works with Drug Courts, probations, jails, local law enforcement/first responders and other community partners to find solutions for this vulnerable patient population. Spero Health is licensed by the state of Kentucky as an Alcohol and Other Drug Entity, in network with all the Medicaid MCOs (85% of our patients are Medicaid members) and accredited under CARF. Patients are seen Same Day/Next Day with almost all our services provided in person.

**Transitions Inc.**: The overarching objective for every level of care Transitions provides is to jumpstart an individual's life in recovery. Transitions does this through individualized treatment planning, patient-centered care, evidenced-based intervention strategies and a compassionate commitment to top-quality care. Its mission is to provide evidence-based, person-centered substance use disorder treatment and recovery services so individuals can lead their most meaningful and healthy lives. Its vision is to be the leading agency for substance use disorder treatment and recovery services in the region. Transition's Core Values—recovery, compassion, ethics, professionalism, staff and alumni—exemplify a commitment to excellence in the quality of care every individual deserves as they begin their journey to sustained recovery.

University of Kentucky Department of Psychiatry SMART Clinic: The UK Department of Psychiatry Supportive Mental Health and Addiction Recovery Treatment (SMART) clinic is a multi-disciplinary outpatient treatment program for patients with substance use disorders. The clinic treats a wide range of substance use disorders using a combination of evidence-based medications (including, but not limited to buprenorphine/suboxone) and group psychotherapy. Patients admitted to the SMART program also receive psychiatric medication management, individual psychotherapy, case management, peer support, primary medical care and hepatitis C treatment if needed. Specialized programming and case management are available for women with substance use disorders who are parenting, seeking to regain parental rights or who have ongoing DCBS cases.

<u>Volunteers of America Mid-States</u>: Volunteers of America Mid-States (VOA) offers addiction recovery treatment that provides individuals with the tools, resources and supports they need to enjoy happy, productive lives. VOA recognizes that treating substance use disorder is both the right and cost-effective thing to do. VOA is especially equipped to deal with justice- and DCBS-involved individuals. It is the only SUD treatment provider in the Commonwealth of Kentucky that allows all children under 18 years of age to stay with their mother while she receives treatment. VOA believes the number and/or age of children should never be a barrier to treatment. Additionally, VOA recognizes that treating substance use disorder alone is not enough. VOA provides programming to all individuals to address parenting, nutrition, budgeting, and other topics essential to success.

## **Biographies**

#### Dr. Timothy Allen

Timothy Allen M.D. is an Associate Clinical Professor and Director of Forensics at the University of Kentucky Department of Psychiatry. He is Board Certified in Psychiatry, Forensic Psychiatry, and Brain Injury Medicine. He has a private forensic practice, with specialization in traumatic brain injury evaluations, and a Transcranial Magnetic Stimulation clinic in Lexington Kentucky. He has been an evaluator of Competency and Criminal Responsibility at the Kentucky Correctional Psychiatric Center since 2003. He frequently reviews applications for testing accommodations for various testing entities including the Law School Admissions Counsel, Chartered Financial Analysts, National Board of Medical Examiners, and multiple state bar examiners.

#### Whitney Allen

On August 4, 2021, Governor Andy Beshear appointed Whitney Allen as Commissioner of the Kentucky Department of Veteran Affairs. Whitney Allen is a retired Army Lieutenant Colonel with 25 years of combined military service. Before assuming his current position, Allen was the Chief of Staff and Deputy Commissioner of the Department. Allen is an advocate for veteran benefits and inclusion in the workforce.

#### Shanalee Applegate

Shanalee Applegate is the Rowan County Clinic Director for Pathways, Inc., in Morehead, Kentucky. She develops community-based programs that benefit youth, families, and the community itself. She manages county finances and employees and oversees dissemination of clinical and administrative information to staff. Applegate also has extensive experience as a mental health outpatient therapist.

#### Dr. Margie Balfour

Dr. Margie Balfour is a psychiatrist and national leader in quality improvement and behavioral health crisis services. She is the Chief of Quality and Clinical Innovation at Connections Health Solutions, which provides 24/7 access to mental health and substance use care throughout Arizona, and an Associate Professor of Psychiatry at the University of Arizona. Dr. Balfour was named the Doctor of the Year by the National Council for Behavioral Health for her work at the Crisis Response Center in Tucson and received the Tucson Police Department's medal of honor for her efforts to help law enforcement better serve the mentally ill population. She is a co-author of the book *People with* Mental Illness in the Criminal Justice System: Answering a Cry for Help and serves on the board of directors of the American Association of Community Psychiatrists, The American Association for Emergency Psychiatry, and NAMI Southern Arizona.

#### Kristin Gray Beach

Kristen Gray Beach has worked in the field of Vocational Rehabilitation for well over 20 years since earning a Bachelor's degree from Georgetown College and her Master's in Rehabilitation Counseling from the University of Kentucky. Kristen is a Certified Rehabilitation Counselor and a Certified Public Manager. With over 10 years experience working with children, youth and families, she is a member of the ZeroSuicide KY team at Pathways and co-facilitator and master trainer for ASIST (Applied Suicide Intervention Skills Training) workshops. Current projects include working with Dr. Walsh, co-creator of the SIPS assessment and Clinical Director at the PRIME Clinic at Yale University, to become a trainer for the SIPS (Structured Interview for Psychosis-risk Symptoms) assessment, which supports the statewide mission to identify and provide access to treatment for young people at risk for developing a psychotic condition.

#### Dr. Patti Clark

Patti M. Clark, Ed.D., MBA, CPS, is the Director of the Division of Mental Health within the Kentucky Department for Behavioral Health, Developmental and Intellectual Disabilities (DBHDID), where she oversees the delivery of mental health prevention, treatment and recovery services for all populations within Kentucky. She is responsible for the state's implementation of 988, the Kentucky Community Crisis Response Team, Disaster Preparedness and Recovery efforts, and crisis service implementation. Dr. Clark began her career in behavioral health in 2006 as the Program Manager for a youth alcohol prevention project in Owen County after a 20+ year career in community newspaper publishing.

#### Honorable Denise Clayton

Judge Denise G. Clayton (ret.) served as chief judge of the Kentucky Court of Appeals from June 2018-December 2022, when she retired from the bench. She had been chief judge pro temp since July 2016. She began serving on the court in October 2007, becoming the first black woman on the Court of Appeals. Prior to her appointment and election to the Court of Appeals, Judge Clayton was chief circuit judge for Jefferson County, where she had been a circuit judge for nearly seven years. She was the first black woman to be a Kentucky Circuit Court judge. Judge Clayton began her legal career as an attorney with the Internal Revenue Service. She also worked at the University of Louisville as the director of student legal services and maintained a private practice. She was the Legal Aid Society of Louisville's associate director before becoming a Jefferson County District Court judge in 1996.

#### Dr. Tracy Clemans

Dr. Clemans is the Project Operations Manager for the University of Kentucky Center on Trauma and Children. She received her Masters of Social Work in 2000 and has worked with children and adults in hospital settings, hospice and palliative care, elementary schools, and community mental health. In 2010 Dr. Clemans received her Doctorate in Clinical Psychology from the American School of Professional Psychology and completed a postdoctoral fellowship with the STRONG STAR PTSD Consortium specializing in the assessment and treatment of traumatic stress, insomnia, and suicidal behaviors. Lt. Spratt was a Hostage/Crisis Negotiator for 19 years and rose through the ranks to become the Commander of the Louisville Metro Police Department Hostage Negotiating Team.

#### Lesanne Story

Lesanne Story is an outpatient therapist with Norton Behavioral Medicine where she works with an interdisciplinary team of medical and mental health professionals, coordinating and providing client care for Norton healthcare patients. She has worked with local agencies as a case worker, clinician and trainer in various roles within Seven Counties services, the Cabinet for Health and Family Services, Family Health Center, and Louisville Metro Department of Corrections. She has served on an interdisciplinary team with the jail medical and mental health staff alongside corrections providing acute crisis care for mentally ill inmates.

#### Dr. David Susman

David Susman is the Executive Advisor for Clinical Services for Kentucky's Department of Behavioral Health, Developmental and Intellectual Disabilities. Stacy Tapke was elected as the Kenton County Attorney on November 4, 2014, and is the first woman in Kenton

Additional honors include receiving the first annual Service to Community Award presented by the Kentucky Bar Association's Young Lawyer Division, the Rising Star award by the YWCA of Greater Cincinnati and she was a member of the 2015 Leadership Kentucky program and 2007 Leadership Northern Kentucky class.

#### Jeremy Thompson

Jeremy Thompson is the Chief of Police for the Elizabethtown Police Department. He oversees 71 sworn personnel and 20 support personnel. Prior to this role, Jeremy served as the law enforcement coordinator for the United States Attorney's Office in the Western District of Kentucky.

#### Honorable Larry Thompson

Kentucky Court of Appeals Chief Judge Thompson has served as a judge in the Commonwealth of Kentucky for over 27 years. He began his career in 1995 as a district judge in Pike County. In 1999, he was elected to the circuit bench, Family Court division, where he served for 20 years. Judge Thompson was elected to the Court of Appeals in 2018, where he now serves as Chief Judge.

#### Marcie Timmerman

Marcie Timmerman is the Executive Director of Mental Health America of Kentucky, where she manages all aspects of the nonprofit including communications, fundraising, volunteers, and annual events. She is a cofounder of the Fund988KY Coalition and the Mental Health Chair for the Kentucky Youth Advocates' Bloom Kentucky Initiative. Prior to her current role, Timmerman was the Health Communications Coordinator for the Kentucky Equal Justice Center.

#### David Trimble

David Trimble is a Kentucky State Police Major with twenty-one years of operational, investigative and administrative experience. He is responsible for overseeing operations within the academy, recruitment, and public affairs branches.

#### Adam Trosper

Adam Trosper currently serves as the State Opioid Coordinator under the Kentucky Opioid Response Effort (KORE) project within Kentucky's Department for Behavioral Health, Developmental and Intellectual Disabilities (DBHDID). With a focus on interagency partnership and collaboration, he administers the State Opioid Response (SOR) program aimed at addressing the opioid crisis. #### Chief Justice Laurance VanMeter

Laurance B. VanMeter was elected to the Kentucky Supreme Court in November 2016 from the 5th Appellate District, comprising Anderson, Bourbon, Boyle, Clark, Fayette, Franklin, Jessamine, Madison, Mercer, Scott, and Woodford Counties. Upon taking office on January 2, 2017, he became just the third Justice to have served at all four levels of Kentucky unified court system. His fellow justices elected him as chief justice of Kentucky for a four-year term that started in January 2023. Prior to being elected to the Supreme Court, Justice VanMeter served thirteen years as a Judge of the Kentucky Court of Appeals, having been elected in November 2003, and being re-elected unopposed in 2006 and 2014.

#### Dr. Sarah Vinson

Dr. Sarah Y. Vinson is a physician who specializes in adult, child and adolescent, and forensic psychiatry. She is the founder of the Lorio Psych Group, an Atlanta, GA based mental health practice providing expert care and

Dr. John J. Wernert has 38 years of experience as a psychiatrist, geriatrician and healthcare policy leader in Kentucky and Indiana. He has served the state of Indiana as Secretary of the Indiana Family and Social Services Administration (FSSA). He has held numerous leadership positions in state and national medical organizations including the AMA and the American Psychiatric Association where he is a Distinguished Life Fellow. Since returning to his home state of Kentucky, Dr. Wernert joined Norton Healthcare as Executive Medical Director for behavioral medicine - working with Norton's primary care and specialty providers, hospital programs, community treatment partners and state policy agencies to build access to medical, psychiatric and addictions services in ambulatory and underserved areas in Louisville and southern Indiana.

#### **Beck Whipple**

Beck Whipple is Kentucky's Suicide Prevention Coordinator. Prior to this, he had fifteen years of experience in promoting the healing of youth who have experienced complex trauma. Beck is a trainer of the following nationally recognized programs and curriculum: Risking Connection, ASIST (Applied Suicide Intervention Skills Training), and QPR (Question, Persuade, Refer). He conducts trainings nationally and throughout Kentucky focusing on providing education and advocacy regarding suicide prevention, trauma, de-escalation and gender identity.
