Judicial Conduct Complaints:

In the 2019-2020 fiscal year, the Commission considered 248 complaints; 227 complaints were concluded, 6 of which resulted in imposed sanctions:

- Two Private Admonitions
- One Private Reprimand:
 - Order of Private Reprimand for violation of SCR 4.300, Rule 4.1(A)(10) and Rule 4.1(A)(7).

Two Public Reprimands:

- Judge Beth Lewis Maze The Commission initiated formal proceedings against Judge Maze on May 21, 2018. On September 24, 2018, Judge Maze entered into an Agreed Order of Temporary Suspension, with pay, effective October 2, 2018, pending final adjudication. The hearing on the Notice of Formal Proceedings and Charges and subsequent amended notices was held October 28-30, 2019. Findings of Fact, Conclusion of Law and Final Order was entered on November 7, 2019 for violations of SCR 4.020(1)(B)(i) and SCR 4.300, Canons 1, 2A, 2D, 3B(2), 3B(7), and 3E(1) and Rules 1.1, 1.2, 1.3, 2.8, and 2.9. Judge Maze has filed an appeal with the Supreme Court; the appeal is under submission.
- Judge Robert F. Wright Agreed Order of Public Reprimand for violations of SCR 4.020(1)(B)(i) and SCR 4.300, Rules 1.1, 1.2, 2.2, 2.3, 2.6, and 2.9.

One Permanent Retirement:

• Judge Allan Ray Bertram - Agreed Order of Permanent Retirement for disability pursuant to Kentucky Constitution § 121, SCR 4.020 *et seq.* and KRS 21.345 *et seq.*



- 227 Number of complaints disposed of during the fiscal year.


Jurisdiction:

Additionally, the Commission has jurisdiction over attorneys who have filed as candidates for judicial office, special judges and participants in the retired judge program under circumstances outlined in the Code of Judicial Conduct.





The Commission accomplishes this mission through its investigation of complaints of judicial misconduct, wrongdoing or disability. In cases where judges, commissioners and candidates for judicial office are found to have engaged in misconduct or to be incapacitated, the Kentucky Constitution authorizes the Commission to take appropriate disciplinary action, including issuing admonitions, reprimands, censures, suspensions, or removal from office.
