NOTICE CONCERNING VACANCY

**IN THE OFFICE OF
CIRCUIT JUDGE
22ND JUDICIAL CIRCUIT, DIVISION 7**

The resignation of the **Honorable Ernesto Scorsone**, effective November 30, 2021, will create a vacancy in the office of Circuit Judge, 22nd Judicial Circuit, Division 7, consisting of Fayette County. **To be eligible to serve as a Circuit Judge must:**

- (a) be a citizen of the United States;
- (b) have been a resident of both the Commonwealth of Kentucky and of the circuit in which you seek appointment for two years next preceding taking office, and
- (c) **be licensed to practice law in the courts of the Commonwealth as well as a licensed attorney for at least eight years.**

The resignation of the **Honorable Joseph T. Bouvier**, effective October 31, 2021, will create a vacancy in the office of District Judge, 22nd Judicial District, Division 1, consisting of Fayette County. **To be eligible to serve as a District Judge you must:**

- (a) be a citizen of the United States;
- (b) have been a resident of both the Commonwealth of Kentucky and of the district in which you seek appointment for two years next preceding taking office, and
- (c) **be licensed to practice law in the courts of the Commonwealth as well as a licensed attorney for at least two years.**

Any person meeting these qualifications and desiring consideration for nomination to the Governor, or any citizen desiring to recommend a person or persons with these qualifications, ***shall notify the Judicial Nominating Commission** by communicating the name(s) *and the vacancy of interest* to the executive secretary on or before **October 13, 2021**, (see SCR 6.030).
