- 6. In the event Pretrial Diversion is ordered, I waive my right to a speedy trial.
- 7. I understand that if the Commonwealth alleges I have violated the terms and conditions of the diversion, the Court will schedule a revocation hearing and, upon completion of the hearing, make a finding as to whether I have failed to comply with the terms and conditions of Pretrial Diversion as ordered by the Court.
- 8. I understand that if the Court finds I have violated the terms and conditions of Pretrial Diversion, the Court will void the diversion agreement and schedule a sentencing hearing. At that hearing, the Court may impose the sentence recommended by the Commonwealth.
