- The Application for an order of protection is **DENIED. (Doc Code: ODRSC)**
- The Application for an order of protection is **GRANTED. (Doc Code: ORSC)** Defendant is restrained from the following:
 - entering Victim's residence _____
 - entering Victim's property _____
 - entering Victim's school _____
 - entering Victim's place of employment _____
 - making contact with Victim; initiating, either personally or through an agent, any communication likely to cause serious alarm, annoyance, intimidation, or harassment including, but not limited to, personal, written, telephonic, or any other form of written or electronic communication or contact with Victim.
 - purchasing/possessing a firearm and/or ammunition (applicable to those convicted of a felony offense, or otherwise ineligible to purchase or possess a firearm under federal law).

Violation of this order of protection is a **Class A misdemeanor**. This order is **enforceable in all Kentucky counties**.

This order of protection shall expire: (Maximum period of order is ten years).
