Defendant having been convicted of violating KRS 189A.010 on \_\_\_\_\_, 2\_\_\_\_\_, and the Defendant **not** having been issued an ignition interlock license under KRS 189A.340 or a hardship license under KRS 189A.410, the Court hereby orders Defendant to physically surrender to the Court any and all license plate(s) currently in force on any motor vehicles/motorcycles owned either individually or jointly by him or her. **THE PERIOD OF LICENSE PLATE IMPOUNDMENT SHALL BE \_\_\_\_\_ DAYS OR \_\_\_\_\_ MONTHS.**  
The order of the Court suspending the license plate(s) shall not exceed the time for the suspension of the operator's license as specified in KRS 189A.070. For a **first offense** within a 10 year period, impoundment shall not exceed six months; for a **second offense** within a 10 year period, impoundment shall not exceed 18 months; for a **third offense** within a 10 year period, impoundment shall not exceed 36 months; and, for a **fourth or subsequent offense** within a 10 year period, impoundment shall not exceed 60 months.
