The court has found, based on this affidavit or sworn testimony, that the child is  a danger to him/herself or to the community, and that "continuation in the home is not in the child's best interest," and/or  in such condition or surroundings that his/her welfare is being harmed or threatened with harm to such a degree that his/her best interest requires that custody be immediately changed from the original custodian to another suitable custodian consenting to temporary custody.

Further, the court has found that:

- Reasonable efforts were made to prevent the child's removal from the home;
- Reasonable efforts were not made to prevent the child's removal from the home;
- Lack of preventive services was reasonable;
- Reasonable efforts to prevent removal were not provided, but reasonable efforts are being made to reunify the family.
- Reasonable efforts to preserve or reunify the child with the child's family are not required pursuant to KRS 610.127.
