

Public Report of Reimbursement -- Q3, FY 19

Rule 3.15 of the Code of Judicial Conduct requires judges to publicly report reimbursement of expenses and waiver of fees or charges permitted by Rule 3.14(A). When public reporting is required, a judge must report the date, place, nature of the activity, and the source of any reimbursement or waiver or partial waiver of fees or charges which the judge received.
