****** SPECIAL PROTOCOLS DURING THE CORONA VIRUS PANDEMIC ******

- MOTIONS TO THE COURT SHALL BE ACCOMPANIED BY A CERTIFICATE OF COUNSEL OR THE PRO SE MOVANT WHICH DETAILS ALL ATTEMPTS THAT HAVE BEEN MADE TO RESOLVE THE DISPUTE PRIOR TO FILING YOUR MOTION. THE CERTIFICATE SHOULD INCLUDE THE DATES AND TIMES OF COMMUNICATIONS, DISCUSSIONS, MEDIATIONS, OFFERS OF SETTLEMENT, OR GOOD FAITH ATTEMPTS MADE TO RESOLVE THE DISPUTE AT ISSUE (EMERGENCY PROTOCOL 6.6).
- IN CASES WITH A “TO BE CALLED” PRE-RULING, ATTORNEYS AND PRO SE LITIGANTS SHOULD LOG-ON TO ZOOM AT <https://zoom.us/j/3939799624?pwd=MUxpZi9zWnU2NXIvZTRnd2E1UUN6dz09> , Password: 620836; OR BY PHONE: (646) 5588656, Meeting ID: 393 979 9624— AT LEAST FIVE (5) MINUTES BEFORE THE START OF MOTION HOUR.
- ANY OBJECTIONS TO THE FOLLOWING PRE-RULINGS MUST BE MADE AT LEAST ONE HOUR BEFORE THE START OF MOTION HOUR AT JeffFamDiv3@kycourts.net OR (502) 595-4326 SO THAT THE MOTION MAY BE HEARD AT MOTION HOUR. YOU MUST HAVE YOUR CASE NUMBER AND THE PARTIES NAMES AND INCLUDE OPPOSING COUNSEL OR PRO SE PARTY ON THE EMAIL OR PHONE (CONFERENCE) CALL TO THE COURT.
- PRO SE LITIGANTS OR ATTORNEYS WHOSE CASE DOES NOT HAVE A “TO BE CALLED” PRE-RULING, OR WHO HAVE NOT FILED A TIMELY OBJECTION, SHALL NOT LOG ONTO ZOOM DURING MOTION HOUR.
- MOTIONS THAT WERE NOT TIMELY FILED OR THAT HAVE NOT BEEN RECEIVED AND REVIEWED BY THE COURT BY THE FILING DEADLINE WILL BE CONTINUED TO THE NEXT MOTION HOUR.
- ATTORNEYS AND PRO SE LITIGANTS SHALL IMMEDIATELY RE-NOTICE A CONTINUED MOTION TO THEIR OPPOSING PARTY. NOTWITHSTANDING, YOU SHOULD CONTACT THE COURT TO CONFIRM THAT YOUR MOTION WAS RECEIVED.
