### Statistics Request Overall Description

On August 28, 2023, Louisville Public Media requested from Research and Statistics a report of capital eligible offenses statewide since 7/1/2002, including charge disposition outcomes.

CourtNet, which provides a summary of cases, was queried for specific capital eligible felony "class A" charges that were disposed from 7/1/2002 – 8/21/2023 within Circuit Court "CR" cases statewide. The following UOR codes were used in the query:

### Statistical Analysis Considerations:

- These statistics represent a snapshot in time from the date the report was queried: 9/14/2023.
- A case may consist of one or multiple charges. The report's count of cases represents a distinct count of case numbers, regardless of the number of charges associated with the case. Counts of cases do not necessarily represent counts of unique individuals.
- Charges consist of all original and amended charges within a case and include ASCF Codes: 1 - Attempt, 2 - Solicitation, 3 - Conspiracy, 4 - Facilitation, 5 - Complicity, 6 - Enhancement.

ordinances, as well as codes for general administrative purposes. When a supplemental code does not appear within a dataset, charge(s) did not occur during this period. The presence of "\*obs" within the description of a UOR code indicates an obsolete UOR code. However, the code is still present within the KYCourts/CourtNet database and may still be utilized. Not every UOR code included in the query will have charges associated with it in each calendar year examined. Some cases may contain multiple charges; therefore, charge counts may exceed case counts. The number of cases cannot be inferred as the number of individuals as multiple cases may have the same defendant.
