Statistics Request Overall Description

On May 25, 2022, the Office of the Commonwealth’s Attorney for the 11th Judicial Circuit requested from Research and Statistics, a report on the number of cases where possession of controlled substance (non-amended) was the highest charge within the case, for the timeframe of calendar years 2017 through 2021.

CourtNet, which provides a summary of cases statewide, was queried for the Circuit Court “CR” cases filed with “possession of controlled substance (PCS)” charges(s) during CY 2017 to CY 2021 in Green, Marion, Taylor, and Washington counties. The case is categorized by the highest felony (PCS) charge. A charge list of the specified offenses by UOR code is included in this report.

Circuit criminal cases (‘CR’) were extracted, containing felony (‘F’) level charges with the following criterion:

- The filing report is based on cases filed 1/1/2017 – 12/31/2021;
- The disposition report is based on cases disposed 1/1/2017 – 12/31/2021;
- when there are multiple charges within the case, extract the highest felony offense per the UOR charge level ranking (maximum level); and,
- when there are multiple highest PCS offenses at the same level with charged, extract the charge with the highest charge entity number within the given circuit criminal case (the highest felony entered last).
- Cases with additional charges other than PCS, which were the lower or of the same charge level and class are reported as separate categories within the report.
- Cases with additional charges other than PCS, which were of a higher charge level and class are excluded from the report.

Statistical Reports (22_RS3034 & 22_RS3025)

Supplemental List of Offenses (22_RS3034) provides a list of “felony possession of controlled substance” (PCS) offenses queried for this report for each county (Green, Marion, Taylor and Washington).

Statistical Analysis Considerations:

- These statistics represent a snapshot in time, as of May 27, 2022.
- The timeframe is derived from 1/1/2017 - 12/31/2021, filings are based on case filing date and dispositions are based on case disposition date.
- A criminal case may consist of one or multiple charges. Excludes cases which have a higher charge(s) other than the PCS within the case, based on the UOR charge level and the class.

The Kentucky State Police (KSP) assigns the Kentucky Uniform Crime Reporting Codes (UOR Codes) to criminal offenses in the Commonwealth of Kentucky. The KSP official list of UOR Codes by KRS number and descriptor can be obtained at the KSP's website at www.kentuckystatepolice.org.

The AOC assigns and maintains codes that are used within the Court of Justice Case Management System for statistical and reporting purposes. These codes are used to identify local and city ordinances, as well as codes for general administrative purposes. The AOC official list of UOR Codes with KRS number and descriptor can be obtained at the Court of Justice Website at <https://kycourts.gov/AOC/Information-and-Technology/Analytics/Pages/default.aspx>. The AOC UOR Code Listing is for informational purposes only and the information is subject to change, reprogramming, modifications of format, and availability at the direction of the Administrative Office of the Courts (AOC).

A query for data based on specified charges will include each UOR code specified and possible supplemental codes. Supplemental codes (or “ASCF” codes) to any UOR code include: 1) attempt, 2) solicitation, 3) conspiracy, 4) facilitation, 5) complicity, and 6) enhancement. In total, UOR codes contain seven digits. The first six digits are specific to that charge. The seventh digit indicates if there is a supplemental code. A “0” as the seventh digit means that is the primary UOR code and it does not have a supplemental code. If there are supplemental codes, the “0” will change to a 1, 2, 3, 4, 5, or 6 (the numbering corresponds to the list above). An enhancement does not exist on all UOR codes. When a supplemental code does not appear within a dataset, charge(s) did not occur during this period. The presence of “*obs” within the description of a UOR code indicates an obsolete UOR code. However, the code is still present within the KYCourts/CourtNet database and may still be utilized. Not every UOR code included in the query will have charges associated with it in each calendar year examined. Some cases may contain multiple charges; therefore, charge counts may exceed case counts. The number of cases cannot be inferred as the number of individuals as multiple cases may have the same defendant.

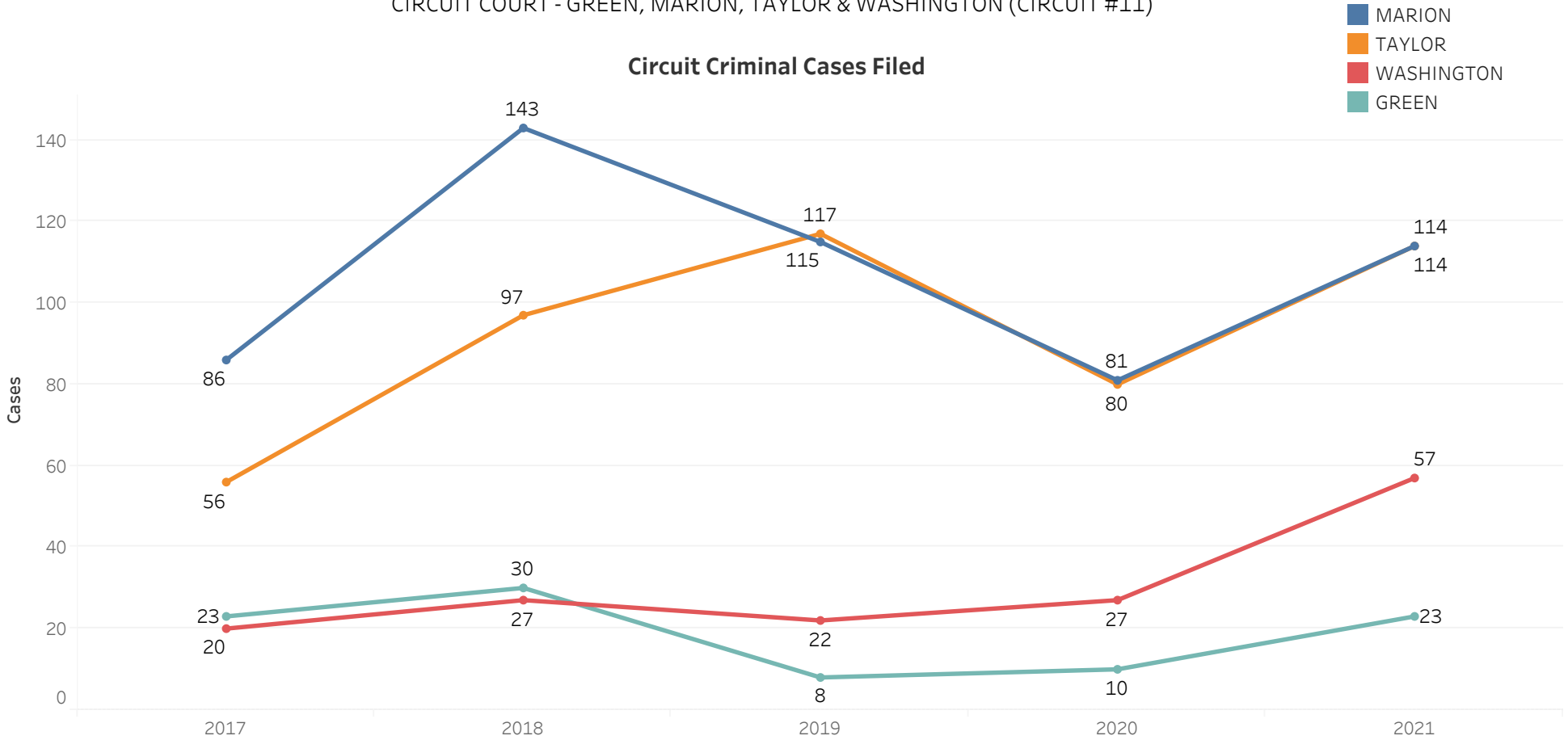

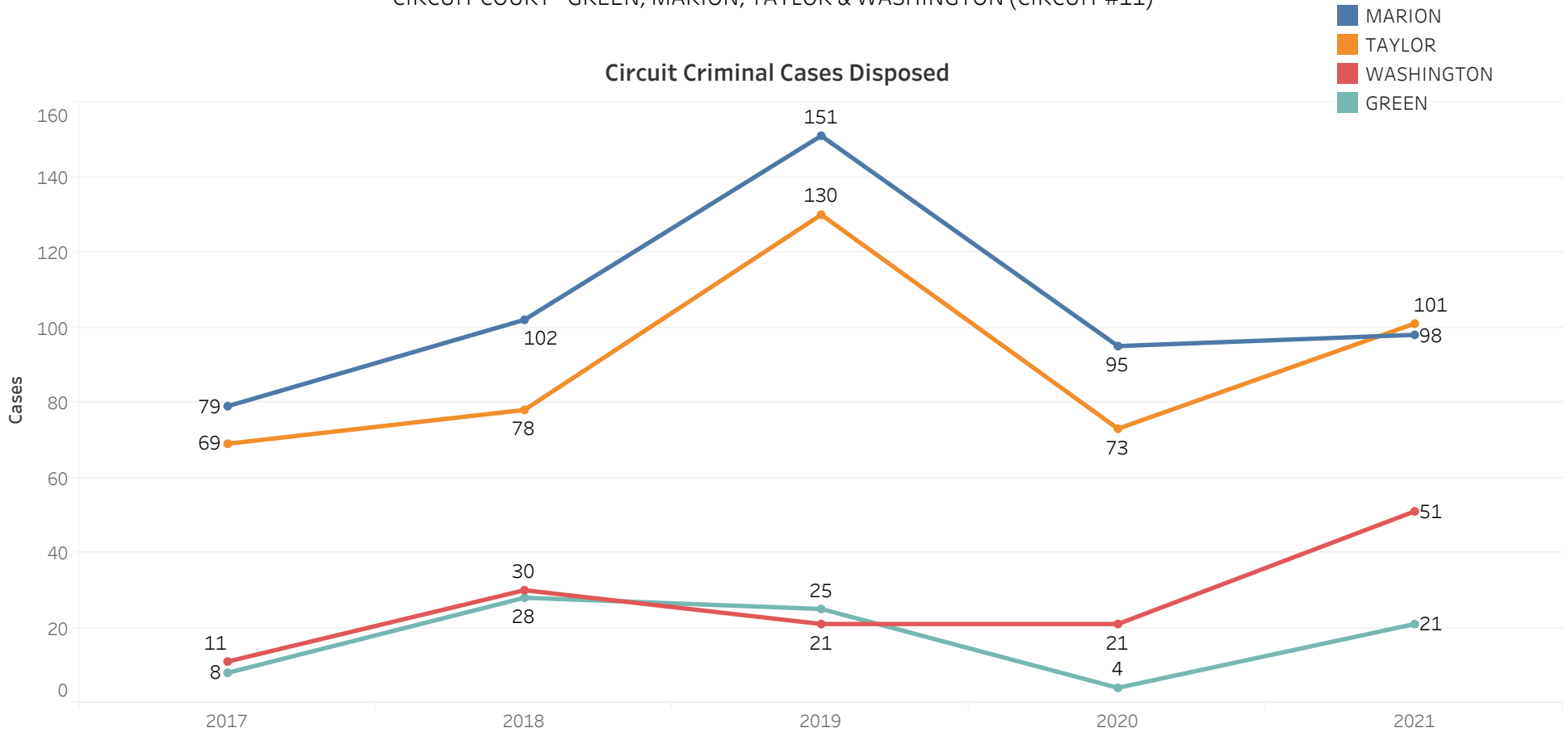
