Statistics Request Overall Description

On April 16, 2024, Research and Statistics received a request for a report of the number of convicted charges related to KRS 510.155 statewide, with no date limit.

The CourtNet database, which provides a summary of cases statewide, was queried for information surrounding all convicted charges associated with KRS 510.155 in criminal cases (*Circuit Criminal*, *District Felony*, *Misdemeanor* or *Traffic* cases). A list of applicable offenses is attached below.

Statistical Table (21_RSX6000 & 21_RSX6022)

Statistical Table 21_RSX6000: Provides a list of the charges queried for the report sorted by Kentucky Revised Statute, UOR Code, UOR Description, and charge level and class.

Statistical Table 24_RSX6022: Provides a single page cross-tabulation with counts of convicted charges associated with KRS 510.155, grouped by charge disposition year, KRS, and UOR Code. Additionally, a count of distinct cases which contain those charges is provided for each grouping.

Statistical Analysis Considerations:

- > Statistics represent a snapshot in time, as of the date the data was gueried: 4/17/2024.
- > A case may consist of one or multiple charges. The report's count of cases represents a distinct count of case numbers, regardless of the number of charges associated with the case.
- > Counts of cases do not necessarily represent counts of unique individuals, as a defendant may have multiple cases.
- > Charges consist of all original and amended charges within a case counted separately.
- > Many but not all charges heard in Circuit Court were previously heard in District Court and indicted by grand jury. As such, the sum of charges in District and Circuit Court will count some indicted charges twice and totals from the two jurisdictions are presented separately.

The Kentucky State Police (KSP) assigns the Kentucky Uniform Crime Reporting Codes (UOR Codes) to criminal offenses in the Commonwealth of Kentucky. The KSP official list of UOR Codes by KRS number and descriptor can be obtained at the KSP's website at www.kentuckystatepolice.org.

The AOC assigns and maintains codes that are used within the Court of Justice Case Management System for statistical and reporting purposes. These codes are used to identify local and city ordinances, as well as codes for general administrative purposes. The AOC official list of UOR Codes with KRS number and descriptor can be obtained at the Court of Justice Website at courts.ky.gov/aoc/statisticalreports. The AOC UOR Code Listing is for informational purposes only and the information is subject to change, reprogramming, modifications of format, and availability at the direction of the Administrative Office of the Courts (AOC).

A query for data based on specified charges will include each UOR code specified and possible supplemental codes. Supplemental codes (or "ASCF" codes) to any UOR code include: 1) attempt, 2) solicitation, 3) conspiracy, 4) facilitation, 5) complicity, and 6) enhancement. In total, UOR codes contain seven digits. The first six digits are specific to that charge. The seventh digit indicates if there is a supplemental code. A "0" as the seventh digit means that is the primary UOR code and it does not have a supplemental code. If there are supplemental codes, the "0" will change to a 1, 2, 3, 4, 5, or 6 (the numbering corresponds to the list above). An enhancement does not exist on all UOR codes. When a supplemental code does not appear within a dataset, charge(s) did not occur during this period. The presence of "*obs" within the description of a UOR code indicates an obsolete UOR code. However, the code is still present within the KYCourts/CourtNet database and may still be utilized. Not every UOR code included in the query will have charges associated with it in each calendar year examined. Some cases may contain multiple charges; therefore, charge counts may exceed case counts. The number of cases cannot be inferred as the number of individuals as multiple cases may have the same defendant.

^{*} Counts of cases do not represent counts of individual defendants as the same defendant may appear in multiple cases.

^{*} A case may have charges with differing UOR codes, which results in that case appearing under a separate row for each distinct UOR code within the case. A case may also have charges with differing disposition years, which results in that case appearing in multiple disposition year rows. Each subtotal displays the quantity of distinct cases and charges for its grouping, causing subtotals of case counts to add up to a number greater than the actual overall total.
