SPECIFIED DOMESTIC VIOLENCE RELATED CHARGES WITHIN CRIMINAL CASES IN FAYETTE COUNTY CY 2021 & CY 2022

Statistics Request Overall Description

On April 24, 2023, the Fayette County Attorney's Office requested a report on criminal cases related to Domestic Violence or Interpersonal Protection (DV/IP) statewide during Calendar Year (CY) 2021 & 2022.

CourtNet, which provides a summary of court cases statewide, was queried for cases filed from 1/1/2021 to 12/31/2022 including at least one of the UOR Codes identified on the attached charge list. Criminal Cases include Case Number Types *CR* (Circuit Criminal), *F* (Felony), *M* (Misdemeanor), *T* (Traffic) and *J* (Juvenile).

Statistical Report 23_RS3067 & 23_RS3068

23_RS3067: Provides the UOR codes included within the query for Fayette County during CY 21-22.

23_RS3068: This report provides aggregate counts of criminal cases filed during CY 2021 & CY 2022, which include at least one charge of an offense indicated on the UOR list (23_RS3067). The cross tables include counts of the charges and a distinct count of cases grouped by AOC Offense Category, UOR Code and UOR Description.

Page 1: Charges in Circuit Criminal Cases Filed (Table 1)

The cross table provides Circuit Criminal cases (Case Number Type *CR*) filed per CY.

Page 2: Charges in District Criminal Cases Filed (Table 2)

The cross table provides District Criminal cases; *Felony (F)*, *Misdemeanor (M)*, and *Traffic (T)* cases filed per CY.

Page 3: Delinquency Cases Filed (Table 3)

The cross table provides Delinquency cases (*J*) filed during CY 2022.

Statistical Analysis Considerations:

- These statistics represent a snapshot in time as of the date the data was queried.
- A single criminal case may have one or more charges.
- Counts of charges include all original or amended charges of the indicated offenses.

The Kentucky State Police (KSP) assigns the Kentucky Uniform Crime Reporting Codes (UOR Codes) to criminal offenses in the Commonwealth of Kentucky. The KSP official list of UOR Codes by KRS number and descriptor can be obtained at the KSP's website at www.kentuckystatepolice.org.

The AOC assigns and maintains codes that are used within the Court of Justice Case Management System for statistical and reporting purposes. These codes are used to identify local and city ordinances, as well as codes for general administrative purposes. The AOC official list of UOR Codes with KRS number and descriptor can be obtained at the Court of Justice Website at [Analytics - Kentucky Court of Justice \(kycourts.gov\)](http://Analytics-Kentucky Court of Justice (kycourts.gov)). The AOC UOR Code Listing is for informational purposes only and the information is subject to change, reprogramming, modifications of format, and availability at the direction of the Administrative Office of the Courts (AOC).

A query for data based on specified charges will include each UOR code specified and possible supplemental codes. Supplemental codes (or "ASCF" codes) to any UOR code include: 1) attempt, 2) solicitation, 3) conspiracy, 4) facilitation, 5) complicity, and 6) enhancement. In total, UOR codes contain seven digits. The first six digits are specific to that charge. The seventh digit indicates if there is a supplemental code. A "0" as the seventh digit means that is the primary UOR code and it does not have a supplemental code. If there are supplemental codes, the "0" will change to a 1, 2, 3, 4, 5, or 6 (the numbering corresponds to the list above). An enhancement does not exist on all UOR codes. When a supplemental code does not appear within a dataset, charge(s) did not occur during this period. The presence of "*obs" within the description of a UOR code indicates an obsolete UOR code. However, the code is still present within the KYCourts/CourtNet database and may still be utilized. Not every UOR code included in the query will have charges associated with it in each calendar year examined. Some cases may contain multiple charges; therefore, charge counts may exceed case counts. The number of cases cannot be inferred as the number of individuals as multiple cases may have the same defendant.
