### Statistics Request Overall Description

On December 12, 2022, the Jefferson County Attorney's Office requested from Research and Statistics a report of domestic violence (DV) related charges within cases filed in Jefferson District Court calendar years (CY) 2019 - 2022.

The CourtNet database, which provides a summary of cases statewide, was queried for DV related charges within cases filed from January 1, 2019, to December 31, 2022, in Jefferson District Court.

### Statistical Reports 21\_RSX4000 and 21\_RSX4001

Two sets of reports are provided:

**MISDEMEANOR:**

- Statistical Report 21\_RSX4000 provides a list of MISDEMEANOR level Uniform Offense Reporting (UOR) Codes that were queried for Statistical Report 21\_RSX4001.
- Statistical Report 19\_RSX4001 provides a count of MISDEMEANOR level DV related charges within cases filed in Jefferson District Court CY 19-22.

**FELONY:**

- Statistical Report 21\_RSX4000 provides a list of FELONY Uniform Offense Reporting (UOR) Codes that were queried for Statistical Report 21\_RSX4001.
- Statistical Report 19\_RSX4001 provides a count of FELONY level DV related charges within cases filed in Jefferson District Court CY 19-22.

Statistical Analysis Considerations:

- The statistics presented are a snapshot in time as of the date the data was queried: 1/12/23.
- A case may consist of one or multiple charges. The report's count of cases represents a distinct count of case numbers, regardless of the number of charges associated with the case.
- Counts of cases do not necessarily represent counts of unique individuals.

These codes are used to identify local and city ordinances, as well as codes for general administrative purposes. The AOC official list of UOR Codes with KRS number and descriptor can be obtained at the Court of Justice Website at [courts.ky.gov/aoc/statisticalreports](https://courts.ky.gov/aoc/statisticalreports). The AOC UOR Code Listing is for informational purposes only and the information is subject to change, reprogramming, modifications of format, and availability at the direction of the Administrative Office of the Courts (AOC).

A query for data based on specified charges will include each UOR code specified and possible supplemental codes. Supplemental codes (or "ASCF" codes) to any UOR code include: 1) attempt, 2) solicitation, 3) conspiracy, 4) facilitation, 5) complicity, and 6) enhancement. In total, UOR codes contain seven digits. The first six digits are specific to that charge. The seventh digit indicates if there is a supplemental code. A "0" as the seventh digit means that is the primary UOR code and it does not have a supplemental code. If there are supplemental codes, the "0" will change to a 1, 2, 3, 4, 5, or 6 (the numbering corresponds to the list above). An enhancement does not exist on all UOR codes. When a supplemental code does not appear within a dataset, charge(s) did not occur during this period. The presence of "\*obs" within the description of a UOR code indicates an obsolete UOR code. However, the code is still present within the KYCourts/CourtNet database and may still be utilized. Not every UOR code included in the query will have charges associated with it in each calendar year examined. Some cases may contain multiple charges; therefore, charge counts may exceed case counts. The number of cases cannot be inferred as the number of individuals as multiple cases may have the same defendant.
