ORDERS TO SURRENDER FIERARMS WITHIN SHELBY COUNTY DOMESTIC VIOLENCE AND INTERPERSONAL PROTECTION CASES DISPOSED CY 2016-2021 HAVING EMERGENCY/TEMPORARY PROTECTION ORDER

Statistics Request Overall Description

On August 8, 2022, Research and Statistics received a request for a report of the proportion of Orders to Surrender Firearms within Shelby County Domestic Violence and Interpersonal Protection Cases with emergency orders of protection.

CourtNet, which provides a summary of cases statewide, was queried for Shelby County Domestic Violence or Interpersonal Protection cases (Case Number Type *D*) with a Case Disposition Date from 1/1/2016 to 12/31/2021 including at least one of the following document types indicating the presence of an emergency protection order:

Among these cases, those having at least one document indicating an order to surrender firearms (Document Type OSF: ORDER TO SURRENDER FIREARMS) were identified.

Of the 658 such cases disposed, 236 cases included at least one Order to Surrender Firearms document (36%).

Statistical Analysis Considerations:

- These statistics represent a snapshot in time as of the date the data was queried (August 8, 2022).
- A domestic violence case may include one or more documents. The counts above are counts of distinct cases.
