Statistics Request Overall Description

On February 23, 2024, Research and Statistics received a request from the Office of the Attorney General for a report of the number of human trafficking charges disposed statewide from the beginning of Fiscal Year (FY) 2021 to present.

The CourtNet database, which provides a summary of cases statewide, was queried for charges disposed statewide from 7/1/2020 through 2/26/2024 which have an AOC Offense Category of human trafficking. A list of all offenses which comprise the data in the report is attached below.

Statistical Table (21_RSX6000 & 21_RSX6002)

Statistical Table 21_RSX6000: Provides a list of the human trafficking charges queried for the report sorted by AOC Offense Category, UOR Code, UOR Description, and charge level and class.

Statistical Table 21_RSX6002: Provides counts of human trafficking charges disposed statewide from 7/1/2020 through 2/26/2024.

Pages 1-4: Provide a cross-tabulation of human trafficking charges disposed in Circuit Court cases by UOR Code and Charge disposition category, with counts provided for charges and a distinct count of cases.

Pages 5-8: Provide a cross-tabulation of human trafficking charges disposed in District Court cases by UOR Code and Charge disposition category, with counts provided for charges and a distinct count of cases.

Pages 9-10: Provide a summary of human trafficking charge dispositions, grouped by jurisdiction and fiscal year.

Statistical Table (21_RSX6000 & 21_RSX6002)

Statistical Analysis Considerations:

- Statistics represent a snapshot in time, as of the date the data was queried: 2/27/2024.
- A case may consist of one or multiple charges. The report’s count of cases represents a distinct count of case numbers, regardless of the number of charges associated with the case.
- Counts of cases do not necessarily represent counts of unique individuals.
- Charges consist of all original and amended charges within a case counted separately.
- Many, but not all, charges heard in Circuit Court were previously heard in District Court and indicted by grand jury. As such, the sum of charges in District and Circuit Court will count some indicted charges twice and totals from the two jurisdictions are presented separately.

A query for data based on specified charges will include each UOR code specified and possible supplemental codes. The first six digits are specific to that charge. The seventh digit indicates if there is a supplemental code. A “0” as the seventh digit means that is the primary UOR code and it does not have a supplemental code. If there are supplemental codes, the “0” will change to a 1, 2, 3, 4, 5, or 6 (the numbering corresponds to the list above). An enhancement does not exist on all UOR codes. When a supplemental code does not appear within a dataset, charge(s) did not occur during this period. The presence of “*obs” within the description of a UOR code indicates an obsolete UOR code. However, the code is still present within the KYCourts/CourtNet database and may still be utilized.
