



DOMESTIC RELATED & SEXUAL OFFENSES WITHIN JUVENILE CASES FILED CY 2007- CY 2021 IN JEFFERSON COUNTY

Statistics Request Overall Description

On May 16, 2022, the Jefferson County Attorney's Office requested a report of juvenile cases filed in Jefferson County in CY 2007 – CY 2021 involving domestic violence and sex offenses.

CourtNet, which provides a summary of cases statewide, was queried for the timeframe of January 1, 2007 to December 31, 2021 for juvenile cases filed in Jefferson county involving sex crimes or domestic violence related charges. See the *Supplemental List of Offenses (22_RS3105)* at the end of the attached report for a complete listing of offenses included in this report.

Statistical Report (22_RS3104 & 22_RS3105)

Report 22_RS3105: Provides a *supplemental List of Offenses* by Category, Kentucky Revised Statute (KRS), and UOR description

Report 22_RS3104 provides juvenile cases filed during the requested timeframe having sexual crimes or domestic violence related charges in Jefferson County.

Page 1: The bar graph (**Figure 1**) provides the count of the specified charges within juvenile cases filed by each CY, and charge disposition category. The cross table (**Table 1**) provides the count of the charges within juvenile cases filed by each CY, along with the distinct count of cases.

Page 2-5: The cross table (**Table 2**) provides the count of the specified charges within juvenile cases filed CY 2007 – 2014 and charge description, along with the distinct count of cases.

Page 6-10: The cross table (**Table 2 continued**) provides the count of the specified charges within juvenile cases filed CY 2015 – 2021 and charge description, along with the distinct count of cases.

Statistical Analysis Considerations:

- The data presented is a snapshot in time as of June 10, 2022.
- Counts of cases should not be considered counts of individuals, as some individuals could be involved with multiple filed cases.
- A case may consist of one or multiple charges. The report's count of cases represents a distinct count of case numbers, regardless of the number of charges associated with the case.
- Charges included in this report include ASCF Codes (1-Attempt, 2-Solicitation, 3-Conspiracy, 4-Facilitation, 5-Complicity, 6-Enhancement); however, only the base charge description is displayed for grouping purposes.

The Kentucky State Police (KSP) assigns the Kentucky Uniform Crime Reporting Codes (UOR Codes) to criminal offenses in the Commonwealth of Kentucky. The KSP official list of UOR Codes by KRS number and descriptor can be obtained at the KSP's website at www.kentuckystatepolice.org.

The AOC assigns and maintains codes that are used within the Court of Justice Case Management System for statistical and reporting purposes. These codes are used to identify local and city ordinances, as well as codes for general administrative purposes. The AOC official list of UOR Codes with KRS number and descriptor can be obtained at the Court of Justice Website at courts.ky.gov/aoc/statisticalreports. The AOC UOR Code Listing is for informational purposes only and the information is subject to change, reprogramming, modifications of format, and availability at the direction of the Administrative Office of the Courts (AOC).

A query for data based on specified charges will include each UOR code specified and possible supplemental codes. Supplemental codes (or "ASCF" codes) to any UOR code include: 1) attempt, 2) solicitation, 3) conspiracy, 4) facilitation, 5) complicity, and 6) enhancement. In total, UOR codes contain seven digits. The first six digits are specific to that charge. The seventh digit indicates if there is a supplemental code. A "0" as the seventh digit means that is the primary UOR code and it does not have a supplemental code. If there are supplemental codes, the "0" will change to a 1, 2, 3, 4, 5, or 6 (the numbering corresponds to the list above). An enhancement does not exist on all UOR codes. When a supplemental code does not appear within a dataset, charge(s) did not occur during this period. The presence of "**obs" within the description of a UOR code indicates an obsolete UOR code. However, the code is still present within the KYCourts/CourtNet database and may still be utilized. Not every UOR code included in the query will have charges associated with it in each calendar year examined. Some cases may contain multiple charges; therefore, charge counts may exceed case counts. The number of cases cannot be inferred as the number of individuals as multiple cases may have the same defendant.

Figure 1: Sexual Crime/Domestic Violence Related Charges within Juvenile Cases by Offense Group per CY

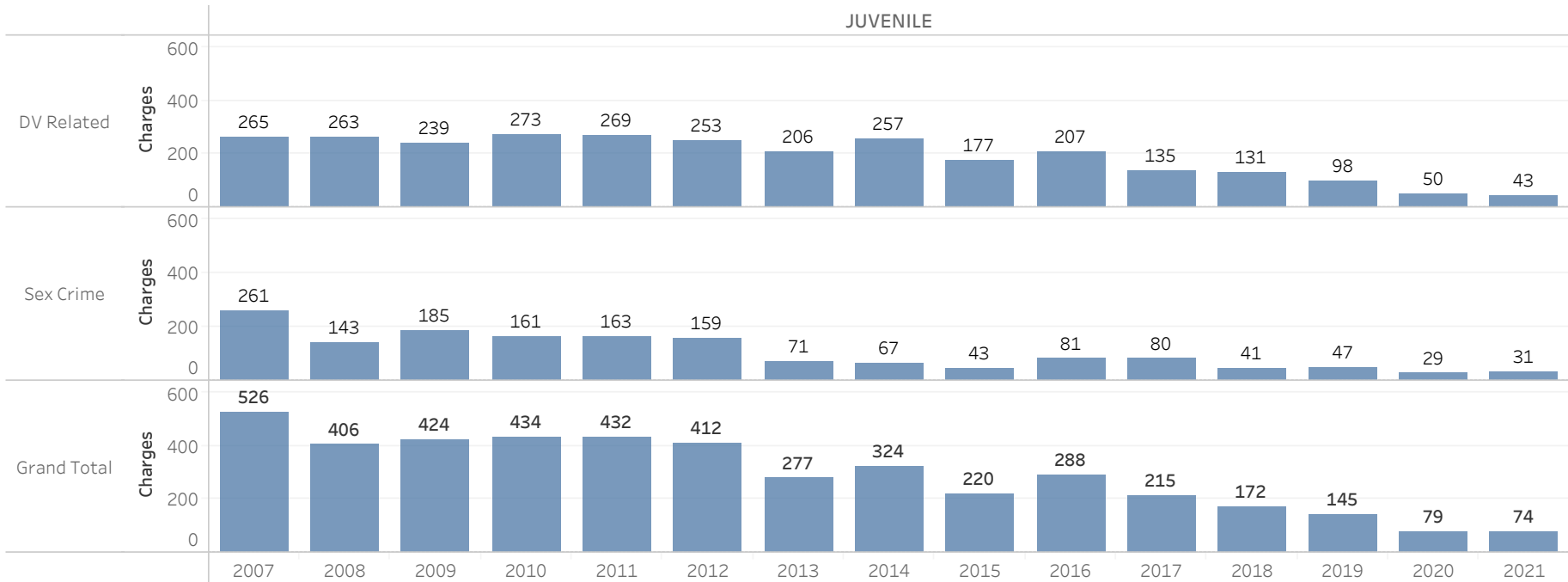
