### Statistics Request Overall Description

On November 9, 2022, the Office of the Jefferson County Attorney requested a count of KRS Chapter 209 charges within cases filed and charges disposed during calendar years (CY) 2017 - 2021 in Jefferson county.

CourtNet, which provides a summary of cases statewide, was queried for charges within cases filed and charges disposed in Jefferson county January 1, 2017 and December 31, 2021.

### Statistical Table (21\_RSX4000, 21\_RSX4001, and 21\_RSX4002)

Statistical Tables:

21\_RSX4000 displays the requested charges queried for this report.

21\_RSX4001 provides a count of the specified charges within cases filed with separate tables for each jurisdiction and is cross-tabulated by UOR code with description and the calendar year.

21\_RSX4002 provides a count of the specified charges disposed, with separate tables for each jurisdiction and is cross-tabulated by UOR code with description and the calendar year.

#### Statistical Analysis Considerations:

- These statistics represent a snapshot in time, as of November 9, 2022.
- This report does not include civil cases, delinquency cases, criminal appeals, or dependency, neglect and abuse cases.
- A case may consist of one or multiple charges. The report's count of cases represents a distinct count of case numbers, regardless of the number of charges associated with the case.
- Counts of cases do not necessarily represent counts of unique individuals. An individual may have multiple cases.
- Charges consist of all original and amended charges within a case.
- Charges include ASCF Codes: 1 - Attempt, 2 - Solicitation, 3 - Conspiracy, 4 - Facilitation, 5 - Complicity, 6 - Enhancement.

A query for data based on specified charges will include each UOR code specified and possible supplemental codes. Supplemental codes (or "ASCF" codes) to any UOR code include: 1) attempt, 2) solicitation, 3) conspiracy, 4) facilitation, 5) complicity, and 6) enhancement. In total, UOR codes contain seven digits. The first six digits are specific to that charge. The seventh digit indicates if there is a supplemental code. A "0" as the seventh digit means that is the primary UOR code and it does not have a supplemental code. If there are supplemental codes, the "0" will change to a 1, 2, 3, 4, 5, or 6 (the numbering corresponds to the list above). An enhancement does not exist on all UOR codes. When a supplemental code does not appear within a dataset, charge(s) did not occur during this period. The presence of "\*obs" within the description of a UOR code indicates an obsolete UOR code. However, the code is still present within the KYCourts/CourtNet database and may still be utilized. Not every UOR code included in the query will have charges associated with it in each calendar year examined. Some cases may contain multiple charges; therefore, charge counts may exceed case counts. The number of cases cannot be inferred as the number of individuals as multiple cases may have the same defendant.
