ORDER CHANGING VIRTUAL PLATFORM AND VIDEO LINK

The Kentucky Administrative Office of the Courts has equipped each courtroom in Bullitt Circuit and District Court with a device which makes Zoom the primary platform for virtual courts in Bullitt District Court effective June 19, 2023. In response to that action and in order to provide a more efficient platform for the operation of Court business it is hereby ORDERED that Bullitt District Court, shall stop using "Microsoft Teams" as its primary virtual platform and begin using "Zoom" as the primary virtual platform on June 19, 2023. Bullitt District Court is in person. All Defendants, attorneys, and any individual wishing to view and/or participate in virtual court proceedings, shall contact the Office of the Bullitt District Judge (502)543-2243 to inquire if they may appear virtually. These links shall only be used with the Court's permission.
